Brief Details.

I was driving along Penang Rd towards Somerset Rd on Lane 2. As I was travelling, I noticed in my left rear view mirror that a taxi was approaching in the lane next to me at a high speed. As the taxi approached, the front driver side of the taxi hit onto the left side of my motorcycle. This caused me to lose balance and swerve to the right. I tried to regain balance, however I could not do so and ended up crashing my bike at the railing along the side of the road.

After the accident, the taxi driver came to me. I asked him to call for the police however he refused to do so and instead call for his taxi company. The driver asked me if I wanted to settle the matter privately, however I felt that it would be better if I called for police. Other drivers stopped and I managed to get their assistance to call for police assistance. I was checked by the paramedics and was conveyed to the hospital. I asked my friend to get a tow truck to bring my bike to a repair shop.

I suffer injuries on my right hand, right jaw, abrasion on right back, cut on right thumb. I have seen a doctor at SGH and was given 5 days MC.

I would like to seek insurance claims against the other driver for causing the accident.
