
### DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

I recall reversing SMH9369G into the car park space successfully. To my left was a concrete post and to my right was another parked car. I remember reversing into the space and giving as much space allowance to the right as possible. However, sensing that the space in between my car and the parked car was rather tight, I decided to move the car off to look for another location with more space. After shifting the car off, I remember alighting from the car to take a look at my car and the next door car (to the right) as I was concerned my car could accidentally come into contact with that car due to the tight space for maneuvering. I was however not able to observe any scratch, dent or damage to the body work of my car or the other car. I therefor proceeded to drive my car off to another location for parking.

The above concludes my report, collating all that I could remember.
