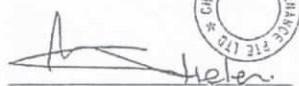

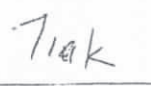

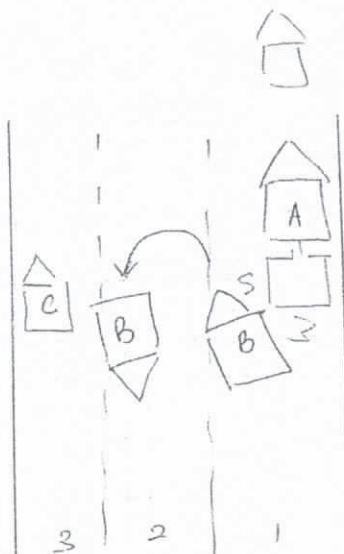

SKETCH PLAN



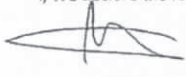
