SKETCH PLAN

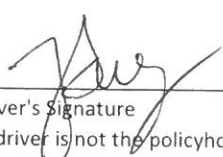

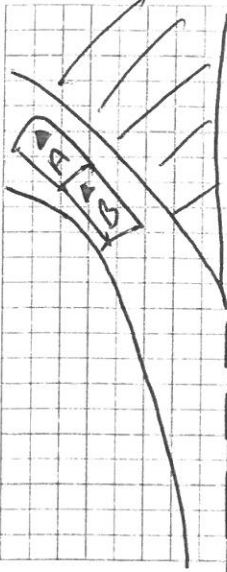
