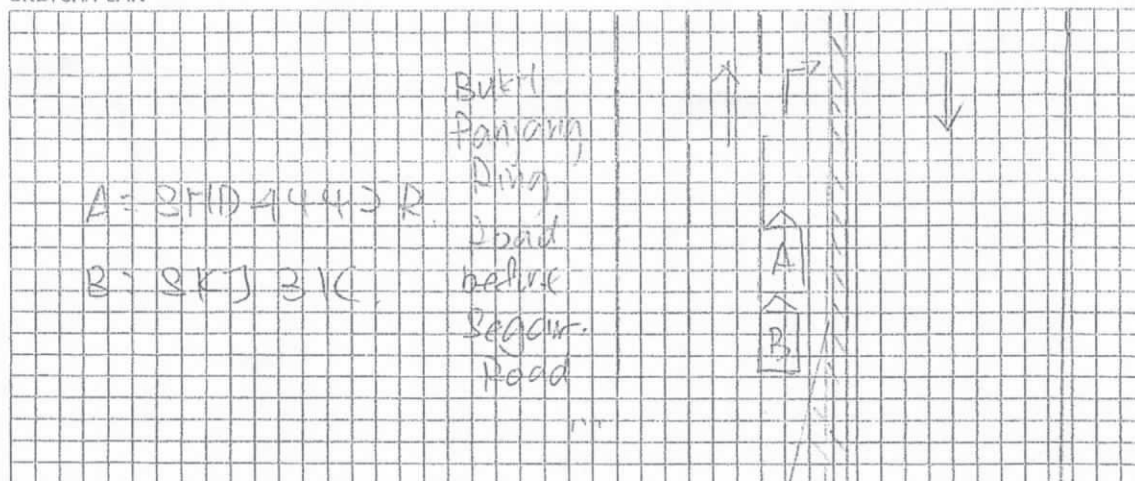

I, Tan Pau Soon, driver of Veh A, was driving along Bukit Panjang Ring Rd going towards Segar Rd, to drop off my passengers (@ BK349). While stopping at the extreme right turning lane, waiting for the traffic to move, Veh B came from behind and hit my vehicle. Spontaneously, I pressed hard on my brake pedal to prevent my vehicle from moving forward & hit the car in front of my vehicle. I took photographs of the accident but when I requested for Veh B's driver's particulars, he refused to cooperate. So I left the accident scene after that to drop off my passengers.
