I was the owner of the vehicle bearing registration number ${\bf SJP4842K}$, a Hyundai Avante – 1.6 HD (A) vehicle.

I am presently working as a Sales Executive with Diners Club and I have been working in this capacity for about 2 and a half months.

The following questions were posed to me by the recorder.

- Q1) Are you the owner of the vehicle SJP4842K?
- A1) Yes.
- Q2) How many set(s) of the SJP4842K's key do you have?
- A2) I have 1 set of vehicle key and I did not bring it for the interview today as I have handed it to the workshop. At the time when I purchase this vehicle I was issue with only 1 vehicle key.
- Q3) Besides you, who else possessed the SJP4842K's key whilst you were away on holiday in Bangkok, Thailand?
- A3) When I was away for my holiday in Bangkok, Thailand I did not bring the vehicle key with me. I placed the vehicle key on an open table top.
- Q4) Prior to leaving Singapore to Bangkok, Thailand, did you authorised and, or permit any one to utilise the SJP4842K?
- A4) I did not authorise and, or permit anyone to drive the vehicle whilst I am away for my holiday in Bangkok, Thailand.



- Q5) Were you the one whom last used/drove the SJP4842K and thereafter having it parked at the multi storey car park of Blk 259 Compassvale Road deck 1B?
- A5) Yes, i was the last person and the only person who utilise this vehicle.
- Q6) To the best of your recollection, who was the last person to access the SJP4842K? A6) No one has access to my vehicle.
- Q7) Were there any modifications made and, or done to the SJP4842K that could possibly contribute to the SJP4842K to be on fire?
- A7) I purchased the vehicle at about 4 months ago. Upon purchasing the vehicle, I did not add-on any modifications such as additional audio systems.
- Q8) When was the SJP4842K last serviced and maintained?
- A8) I was told by the sales person namely Mr Paul Foo (mobile: 9750 5007) that this vehicle was serviced with replacement of car battery at about 1 week before handing over to me.
- Q9) The SJP4842K was serviced and maintain by which workshop? A9) I do not know.
- Q10) When did you purchase the SJP4842K?
- A10) I have provided the sales agreement to you.
- Q11) Are you willing to provide the Sales Agreement for the SJP4842K?
- A11) Yes, I have provided.
- Q12) Aside from you, who else usually utilises and, or drives the SJP4842K?
- A12) No one else.
- Q13) Are you able to provide documentation proof / materials to show that you were not in Singapore at the time of the incident?
- A13) Yes and I have provided.
- Q14) At present, are you going through any financial situation which is / may not be in your favour?
- A14) No, I am not going through any financial difficulty situation in this time.





Q15) Do you have and, or own any company(s) at present?

A15) I have registered one company when I was driving for GRAB.

Q16) Were / Are there any people and, or person that you may have offended in recent times?

A16) No. No such occurrences.

Q17) Are you a qualified Private Hire Driver? If 'No', please explain the Private Hire Vehicle decal that was discovered on the front and rear windscreen of the SJP4842K. A17) Yes, I am.

Q18) Was/ Were the Police/Traffic Police and ambulance activated to the accident scene?

A18) I never received any notifications from them. I was briefly told by the Police IO that likelihood of the fire was caused by electronic and, or wiring issues and no mischief involved in this case.

Q19) Is your vehicle fitted with in-car camera, if 'Yes' could you provide us the video footage?

A19) No, it is not fitted.

Q20) Did you take any accident scene photographs whilst at the scene? If 'Yes' are you will to provide it to us?

A20) I was away from State hence I was unable to capture any incident photos.

Q21) When was the vehicle last used by you?

A21) I last used the vehicle and parked it in the incident car park lot on the 146/2019 at about 1430 hours.

On 13/6/2019 at about 1000 hours, I used the vehicle and drove it to my sister's house located in the vicinity of River Valley from home.

Thereafter, the vehicle was parked at my sister's condominium until the following day to drive back home.
