KETENTUAN PIDANA

2. Setiap orang yang mengemudikan Kendaraan Bermotor di jalan yang tidak dapat menunjukkan Surat Izin Mengemudi yang sah dipidana kurungan paling lama 1 (satu) bulan atau denda paling banyak Rp 250.000,00 (dua ratus lima puluh ribu rupiah). Pasal 263 ayat 2 Undang-undang nomor 22 tahun 2009.
3. Selain pidana penjara, kurungan, atau denda, pelaku tindak pidana Lalu Lintas dapat diadili pidana tambahan berupa Pencabutan Surat Izin Mengemudi atau ganti kerugian yang disebabkan oleh tindak pidana Lalu Lintas. Pasal 314 Undang-undang nomor 22 tahun 2009.
4. Penahanan pelanggaran Lalu Lintas pada SIM diakukan seluas 30 hari dengan pencatatan pada pangkalan data Pengemudi secara elektronik dan atau manual. Pasal 73 ayat (1) Peraturan Kapolri Nomor 3 tahun 2012 tentang Surat Izin Mengemudi.


