Accident Sketch Plan

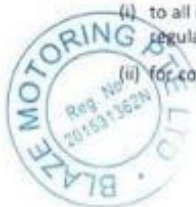

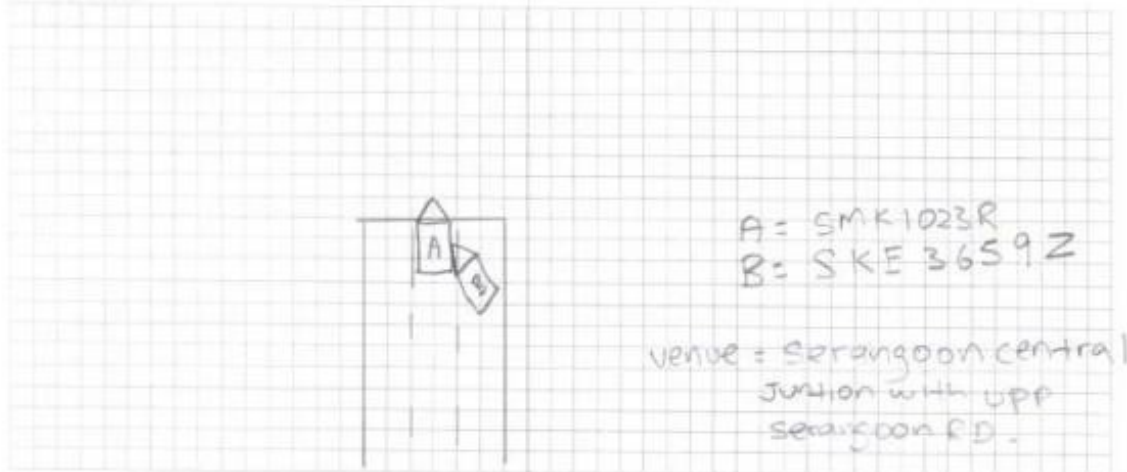

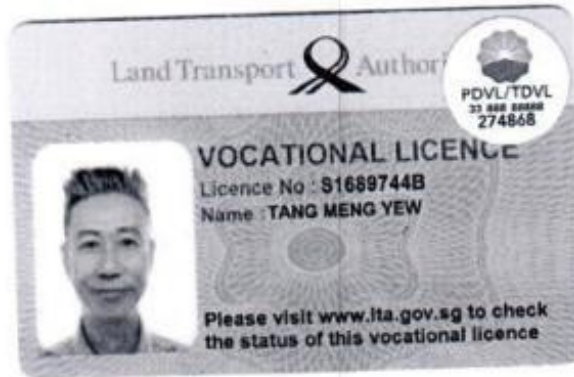
