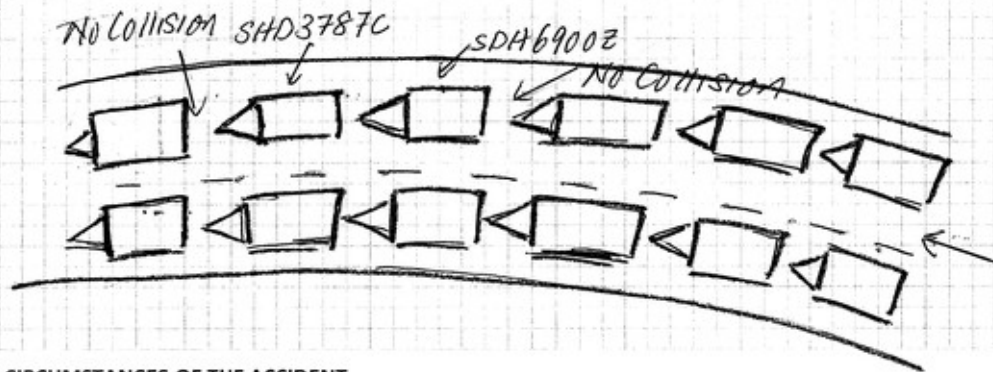

## DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

On 20 Jun 2019 (Thursday), at approximately 1910hrs, whilst travelling along Newton Flyover in the direction of Newton Circus, there was a heavy traffic jam and my car, a Silver Toyota Camry, Licence Plate No: SDH6900Z, driven by myself, NRIC: S1728608J, Mr. Phua Chai Jit, came to a complete halt behind Comfort Delgro Taxi, Model: Hyundai Ioniq (Blue in colour), Licence Plate No: SHD3787C, driven by NRIC: S6933518G; Mr Tan Kim Hoo. My son was seated in the back of my car whilst Mr. Tan was carrying several passengers in his taxi.

Due to the slight downward gradient slope on the Newton Flyover, my car inadvertently rolled forward slightly and grazed the back of his taxi. Both drivers exited from their cars and inspected their vehicles. The taxi sustained slight grazes on the rear licence plate whilst my car sustained slight grazes on my front licence plate but there was no major damage to both vehicles. We also confirmed that there were no injuries to myself, my son, taxi driver and his passengers.

P.S. The slight delay in reporting was due to a private settlement and the settlement was negotiated over the weekend, 22 Jun 19 (Sat) & 23 Jun 2019 (Sun).
