Thank you for your email.

I have submitted a copy of my driving license, the traffic police report detailing my account of the accident which includes a sketch plan and about 10 coloured photographs to Eurokars. Please confirm that you have a copy and let me know if there is anything else you need.

I would like to say that the two cars in front had already collided or come to a complete stop on the downslope and it was impossible for me to stop my car to avoid the accident as there was no visibility coming from the upslope on the expressway and the emergency brakes were ineffective when applied on the downslope.

Unfortunately I only discovered after the accident that the memory card of the video camera was spoilt and therefore do not have a recording of the accident which would have verified my account. However, the photographs would be able to show the upslope location and position of the vehicles.
