
Accident Sketch Plan

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

Date of Accident: 25 June 2019

Time of Accident: 1930 PM

Location of Accident: Westgate Shopping Centre, Basement 2 Carpark Column 16

I was driving my vehicle (No: GBH 9852H) along a driveway of basement 2 carpark of Westgate Shopping Centre, facing East toward the exit on a straight direction.

After I crossed the junction near column No. 16, vehicle No. SME 7414M turned right into my way and hit on the right side portion of my vehicle, damaged the sliding door and other part of my vehicle.

Driver of vehicle SME 7414M, Mr. Sean Yap admitted it was his own fault for causing the collision and requested for private settlement of compensation for the repair cost.

After further discussion, it was decided to proceed for insurance claim.
