I am the above-mentioned person and owner of the above address. I have a valid class 3 Singapore license since 10 May 2002. Prior to the accident, I had 17 years and 1 month of driving experience. For the past 3 years, this was the first time that I am involved in a road traffic accident in Singapore.

The ownership and policyholder of motorcar bearing registration no: SKK977T is registered under my girlfriend, Ms Aw Hui Ling Andrea, Nric: S8433112J. I am given permission by the Insured to drive the said motorcar whenever I wish to drive. On the 24 June 2019 at about 1320 hours, at the carpark exit of Mandarin Orchard Singapore (Hotel), I am the driver that was involved in a road traffic accident. Before the occurrence, I have been driving the said vehicle for about a year. I was conveying my girlfriend, Ms Andrea Aw (Insured) at the front passenger seat on board the said vehicle from basement carpark of Mandarin Orchard Singapore (Hotel) and proceeding to Bugis when the accident took place.

At the material time, the traffic flow was heavy, weather was fine, visibility was clear and the road surface was dry. I was conveying my girlfriend on board the motorcar bearing registration no: SKK977T and driving out from basement carpark of Mandarin Orchard Singapore (Hotel), heading towards the exit onto Orchard Link. I was travelling at an approximate speed of 5 km per hour on the single lane, upward slope car park driveway.

Upon reaching the exit of Mandarin Orchard Singapore (Hotel), I halted behind a motor taxi bearing registration no: SHC6319G, waiting to turn right onto Orchard Link. At this juncture, my vehicle was partially on the upward slope and on my left was a stationary vehicle bearing registration no: SLM3077Z. Shortly, the traffic at Orchard Link cleared and the motor taxi SHC6319G proceeded to exit. Thus, I proceeded to inch forward to turn right onto Orchard Link, after checking that my path was cleared.


In the midst of inching forward, the motorcar SLM3077Z suddenly overtook my vehicle on the left, instead of giving way to me. As such, the right rear portion of motorcar SLM3077Z subsequently grazed onto the front left bumper of my vehicle. The motorcar SLM3077Z was on my left and supposed to give way to vehicle on the right. Furthermore, my vehicle was partially on the upward slope and therefore had the right of way to vehicle on the left.


After the collision, I alighted from my vehicle and spoke to the driver of motorcar SLM3077Z, a Chinese man in his fifties, who was conveying 3 male passengers on board his vehicle at the time of accident. From my observation, the said driver and his 3 passengers appeared to be unhurt with no visible injury on them. Likewise, my passenger and I were unhurt in the accident. Both drivers affirmed that no one was injured in the accident. Therefore, the Police and ambulance services were not summoned to the scene.

Due to the light collision, there were slight scratches on the front left bumper of my vehicle and rear right bumper of motorcar SLM3077Z. At the scene, I took photographs of the damages to respective vehicle in their original position. Both drivers exchanged particulars and left the scene on separate ways.

After the accident, I lodged Police and insurance reports pertaining to this accident. A video footage of the accident was obtained from the management of Mandarin Orchard Singapore (Hotel). My passenger and I were not injured in the accident. The Insured and I affirmed that we are not making any claim in this matter. In the event of a Third Party claim against me arising from this accident, we agree to let the Insurer, AXA handle the matter on our behalf.

My vehicle was not installed with an in-car camera and there was no independent eye-witness to this accident. At the material time, I was not driving under the influence of any alcohol or medication.
