Accident Sketch Plan





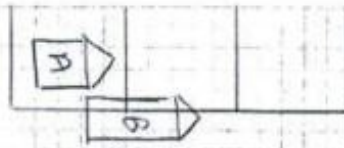

B - YN 1125Y


