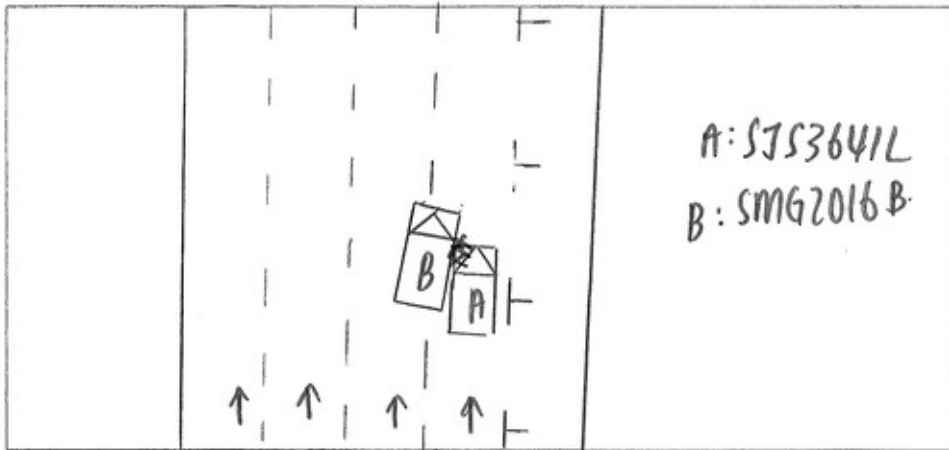

Accident Sketch Plan





