Brief Details.

I was travelling along PIE towards Changi Airport before Eunos Exit 8 on Lane 1 at around 227pm on Sunday. As far as I observed, the stoppage of the Taxi (SHD6076B) was caused by another vehicle (Maserati SKT109K) and more vehicle pileup, nonetheless further details in front are not visible from my point of view.

The airbags on my vehicle has been deployed, and I've proceeded to visit the hospital for an X-Ray and Ultrasound checkup due to pain from the impact.
