#### Circumstances of Accident

Circumstances Of Accident #straightroad Accident\_Scenario Moving straight & Moving straight Blue Car SLK7017G White Car SJV 8054H 1) I was responsible for a head-to-rear collision by my vehicle on the vehicle in front of me. It took place on the extreme right lane of the PIE towards Jurong. The vehicle in front of me was slow-moving almost stationary when I hit it. 2) The driver of the other vehicle (Mr Kay Kah Hock) came out of the vehicle and had an amicable chat with me in which we exchanged our particulars and he said he would make claims depending on damage to his car and I said I would wait for him to make claims. Mr Kay was perfectly healthy during that conversation. There was a dent to the back of his car and disfigurement of the number plate of my car as evidenced by the photos I've attached. Apart from that there were no signs of damage. There were also no signs of any injury on Mr Kay who was moving perfectly normally. 3) Today I received a letter from Riaz LLC Advocates and Solicitors on behalf of Mr Kay claiming that Mr Kay suffered back injuries and had medical expenses in excess of S\$5 000 as a result of the collision caused by me. 4) Because my vehicle is covered under an AIG policy (policy number 2100498950-01) I'm reporting this so that the appropriate amount can be paid to Mr Kay. Under my policy injury of a third party as a result of an accident is covered. 5) Evidenced by the minimal damage to both vehicles (as per attached photos) and the healthy condition of Mr Kay immediately after the collision I'm extremely surprised to hear that he suffered back injuries as a result of the collision. 6) As such I kindly request AIG to investigate the accuracy of the claims before agreeing to an appropriate amount. 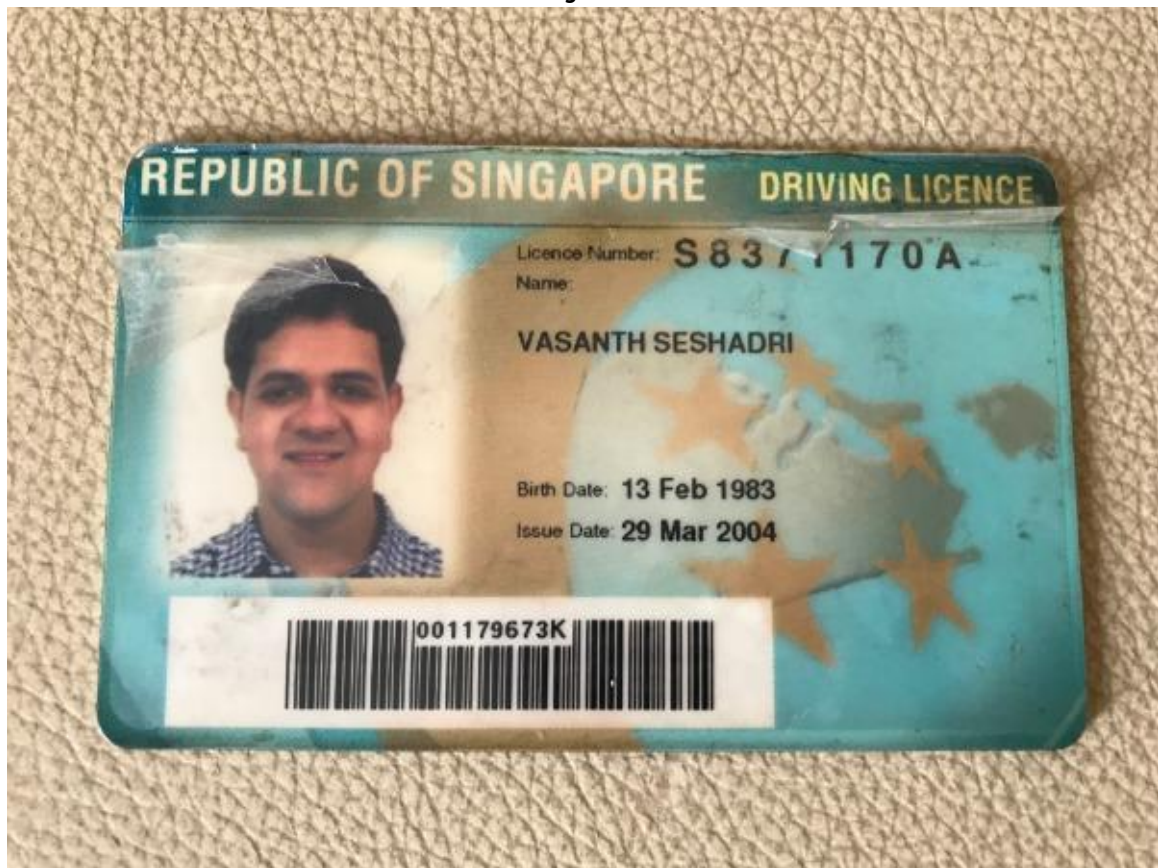

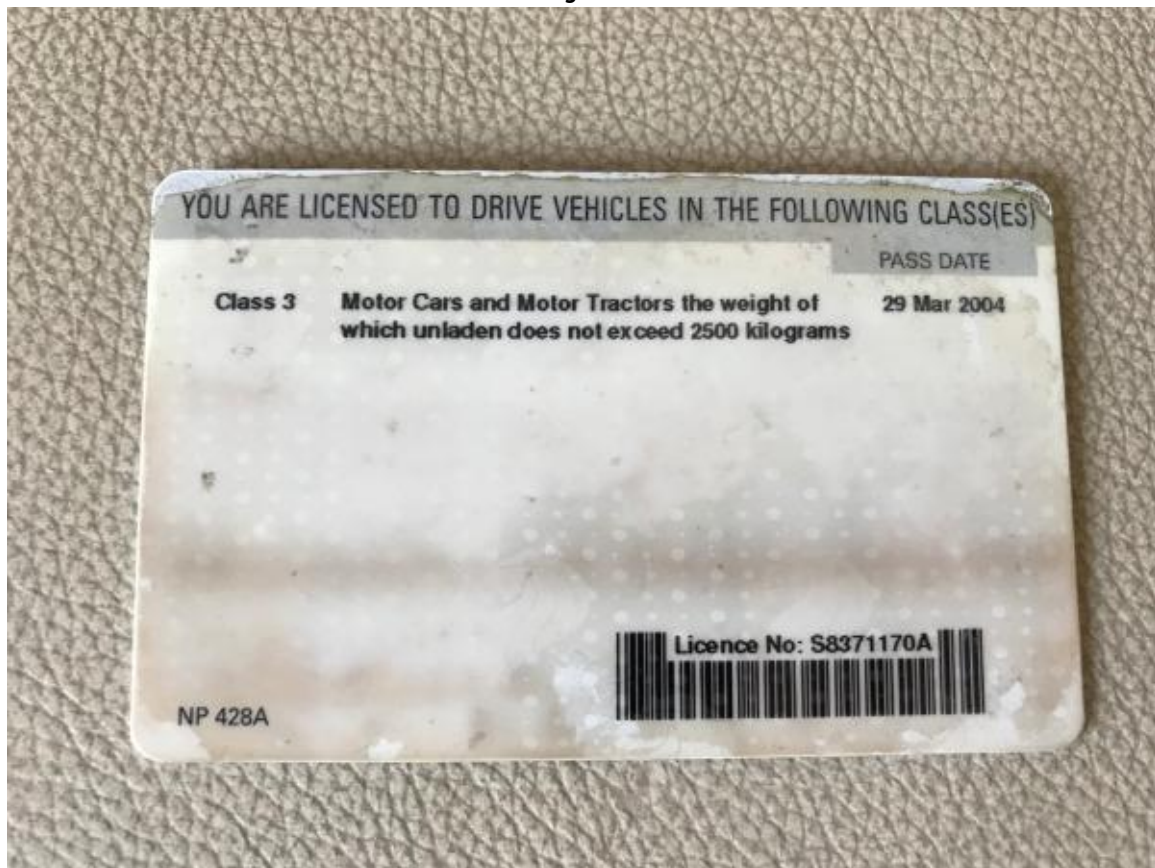
