- Hirer/Hirer's authorised driver is liable for all parking and traffic violations. All accidents involved/insurance excess vehicle is rented upon conditions shown on this page and on the reverse hereof. Hirer confirms he has read, understood and agree to the conditions.
- Hirer and his authorised driver jointly and severally declare that the vehicle will not be used for any unlawful purpose which will result in its forfeiture by the relevant authorities.
