Circumstances of Accident

ON 28TH JUNE 2019, I WAS TRAVELLING ALONG THE SLIP ROAD LEADING ONTO CHANGI BUSINESS PARK CENTRAL 1 FROM CHANGI SOUTH AVENUE 2 IN CAR A. THE TIME WAS 7:30PM. I WAS QUEUING TO ENTER CHANGI CITY POINT CARPARK, AND THE QUEUE WAS LONG AND IT WAS START-STOP TRAFFIC. AS THE CARPARK QUEUE CLEARED, I PULLED OUT SLOWLY, AND TURNED ONTO CHANGI BUSINESS PARK CENTRAL 1. CAR B WAS IN MY BLIND SPOT, AND I DID NOT SEE HIM TRAVELLING STRAIGHT. THE RIGHT FRONT BUMPER OF MY CAR A HIT THE LEFT PANEL AND WHEEL OF CAR B AT SLOW IMPACT. NO ONE WAS INJURED IN THIS INCIDENT.

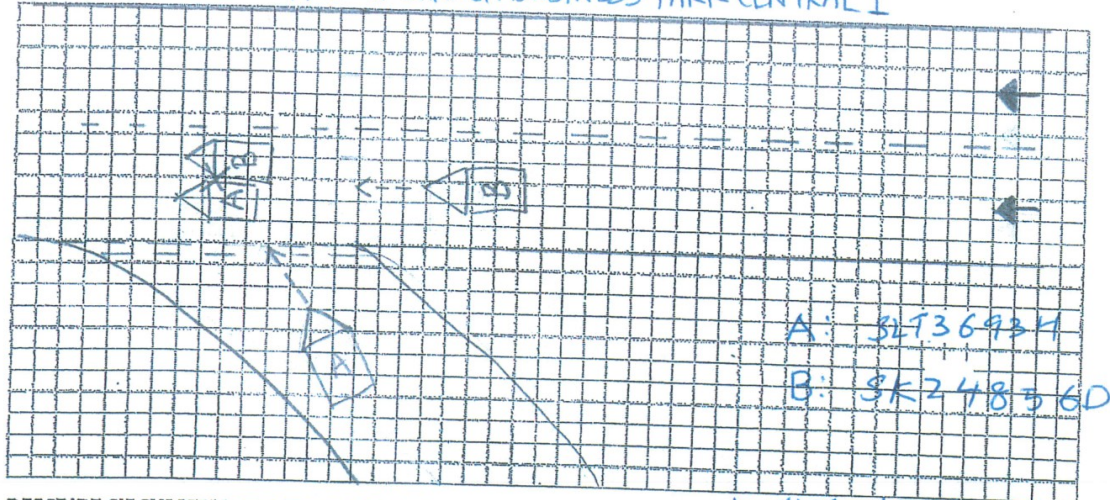

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

On 28th June 2019, I was travelling along the slip road leading onto Changi Business Park Central 1 from Changi South Avenue: 2 in Car A. The time was: 7:30pm.

I was queuing to enter Changi City point car park, and the queue was long and it was start-stop traffic.

As the car park queue cleared, I pulled out slowly, and turned onto Changi Business Park Central 1. The car B was in my blind spot, and I did not see him travelling straight. The right front bumper of car A hit the left panel and wheel of the car B at star impact.

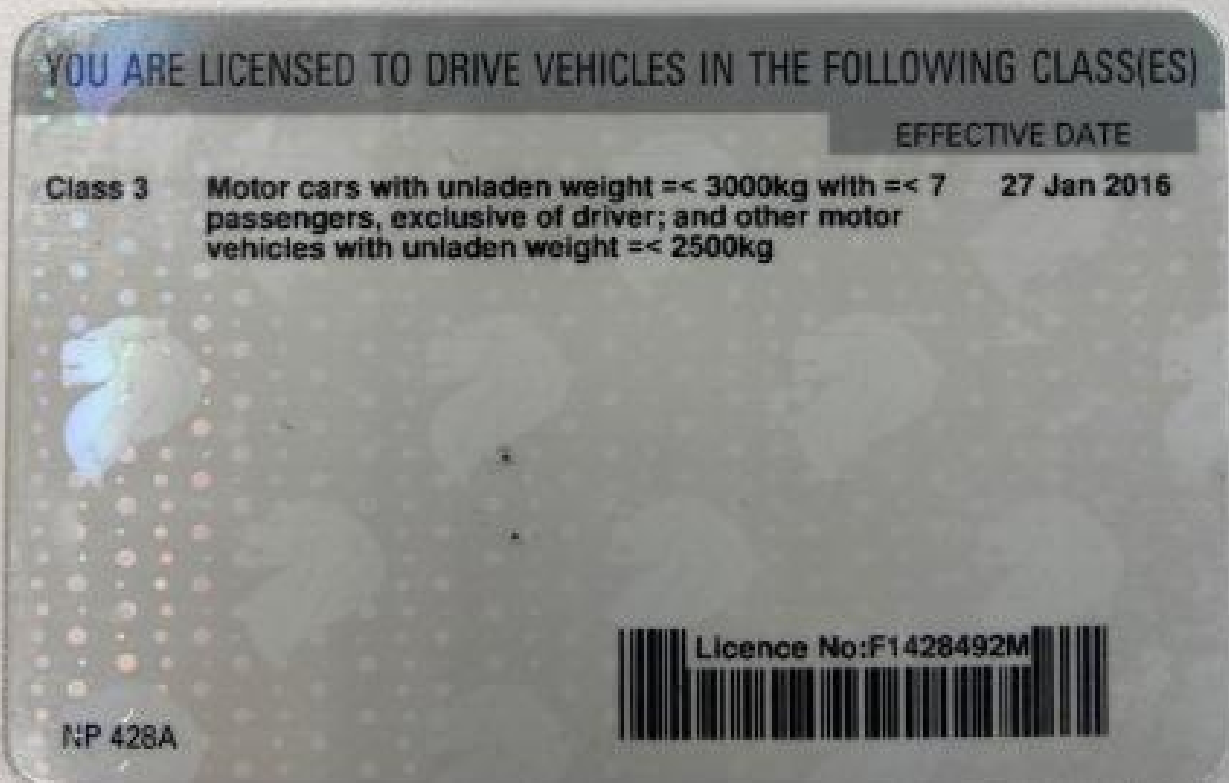

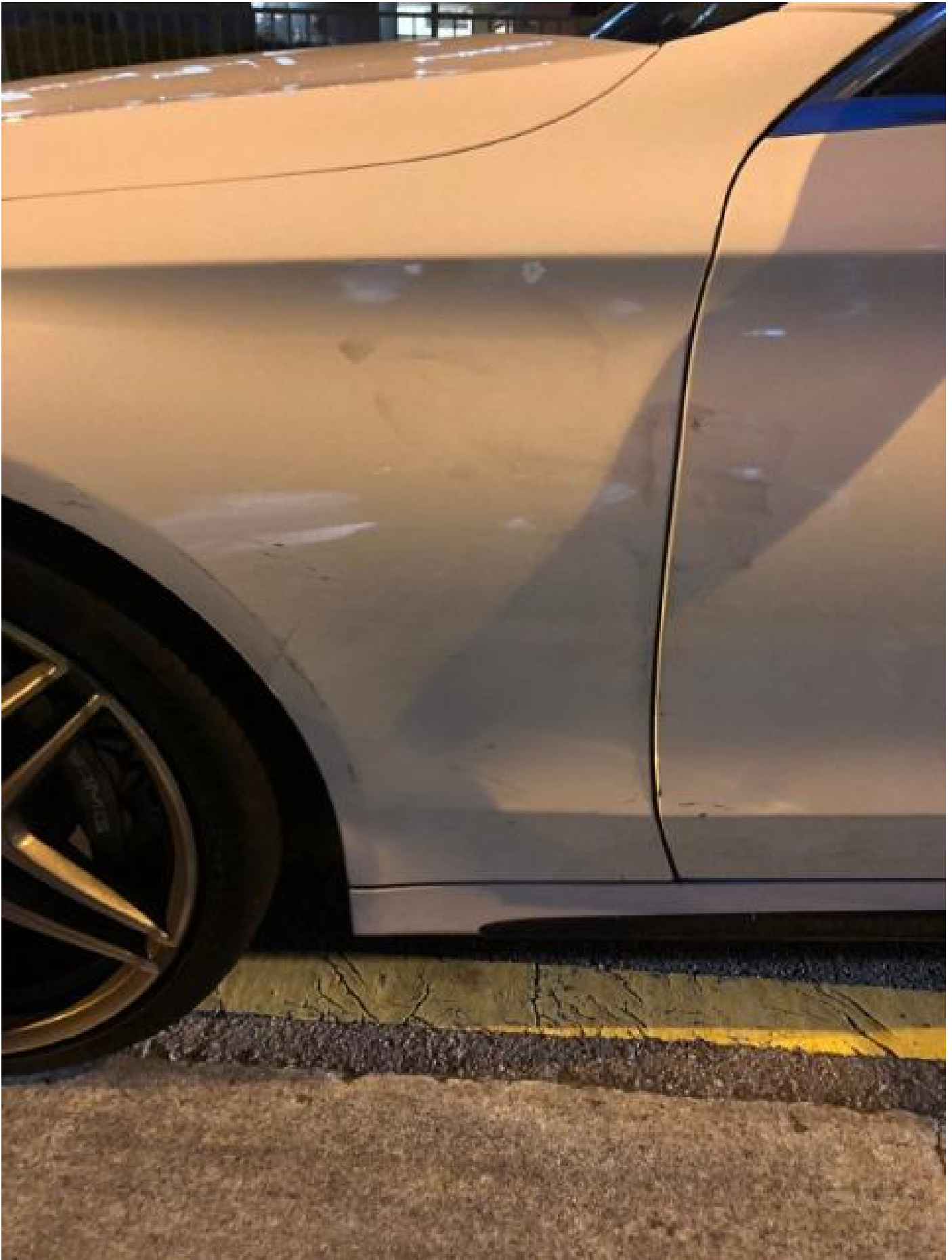
