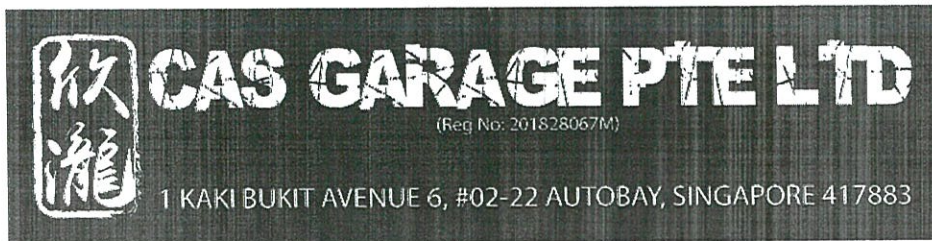

- I/we have read and understand the above statement and agreed.


