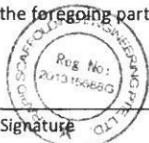
DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

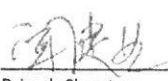
I vehicle 'A' GBG7303M was travelling on the stated route.

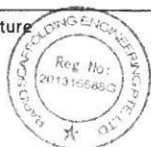
