Brief Details.

On 19/04/2019 at about 0600hrs, I was riding my motorbike JTH2483 along Prinsep Street with my Pillion Ang Wan Ching.

There was a lorry ahead of me. I was riding at a slow speed at that point of time.

Then the lorry driver abruptly made an illegal U turn. I was unable to stop on time and collided on the side of the lorry.

My motorcycle was damaged and towed away. My pillion and I were conveyed to Tan Tock Seng Hospital.

I suffered abrasions on my right hand, elbow and left leg. I received outpatient treatment in Tan Tock Seng Hospital.

My pillion Ang Wan Ching suffered cuts on the head and knees which required stiches. She also suffered abrasions on the left hand and shoulder blade. She was admitted in tan Tock Seng Hospital and was discharged on 22/04/2019.

The Police were at scene. I was advised to lodge a traffic Accident report.
