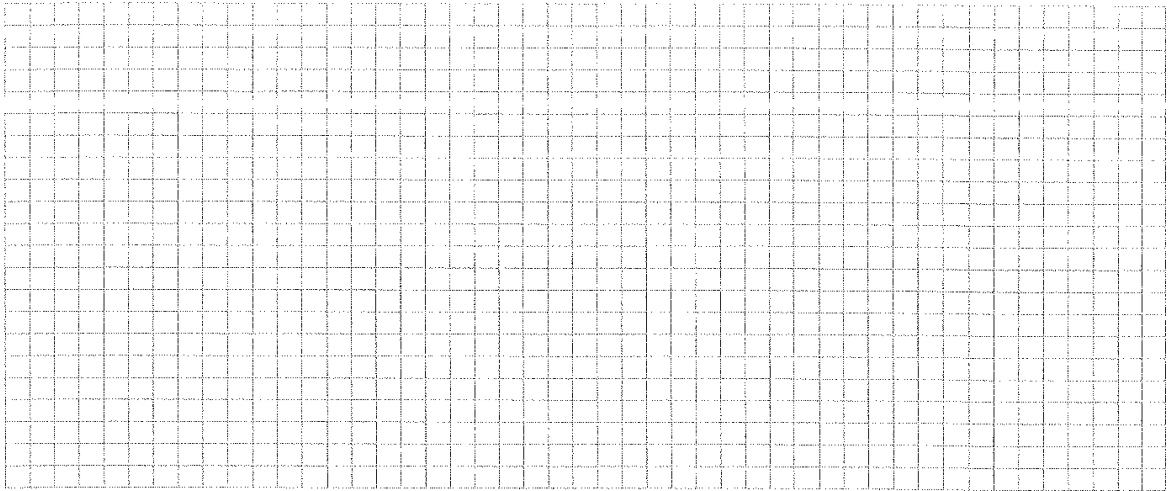

 I go n its no damage at all.

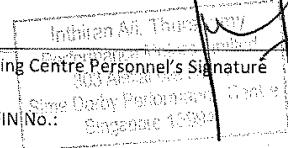
