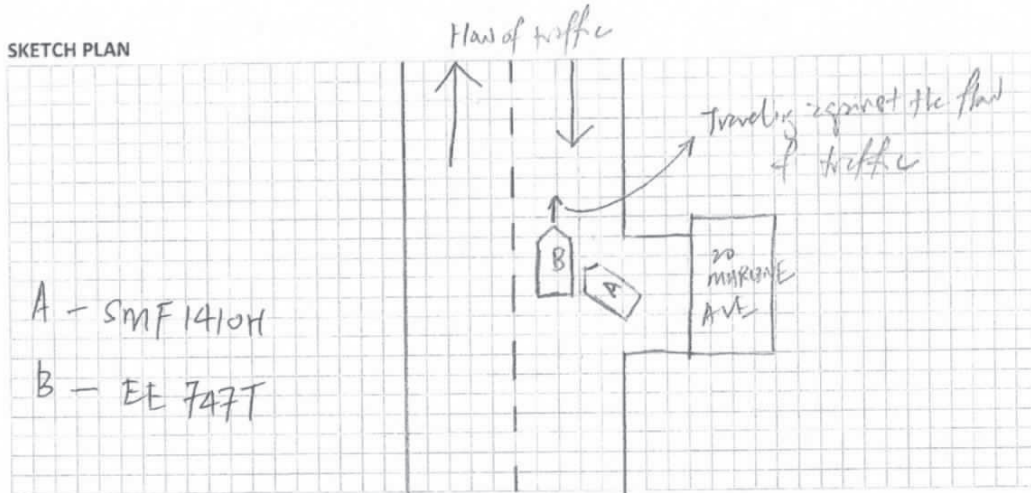

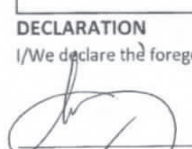


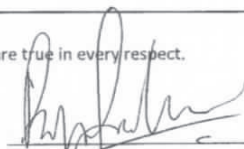
DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

I was in my car just outside of my house, 20 MARLENE AVENUE on 21/6/19 at approximately 12pm. I was looking to make a right turn, and was checking both my left and right side. A car driving against the flow of traffic hit my car on the left, damaging my left bumper. There was no impact damage on the front of my car / its right side. When I spoke to the driver after, he admitted that he was driving in the wrong lane. The right rear end of his car hit the left bumper of my car. During the incident, the impact of his car hitting mine dislodged my licence plate, and his vehicle dragged it forward a couple of metres. The driver of the other car stopped his vehicle in the lane he was driving in (against the flow of traffic - see attached photos).
