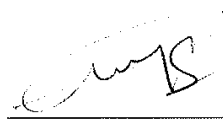

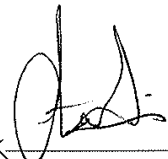

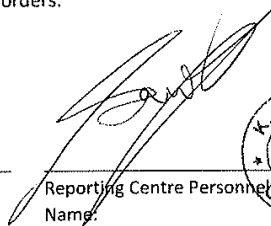

SKETCH PLAN

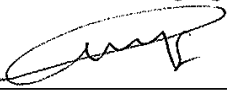
PURSE REFER SCCT
