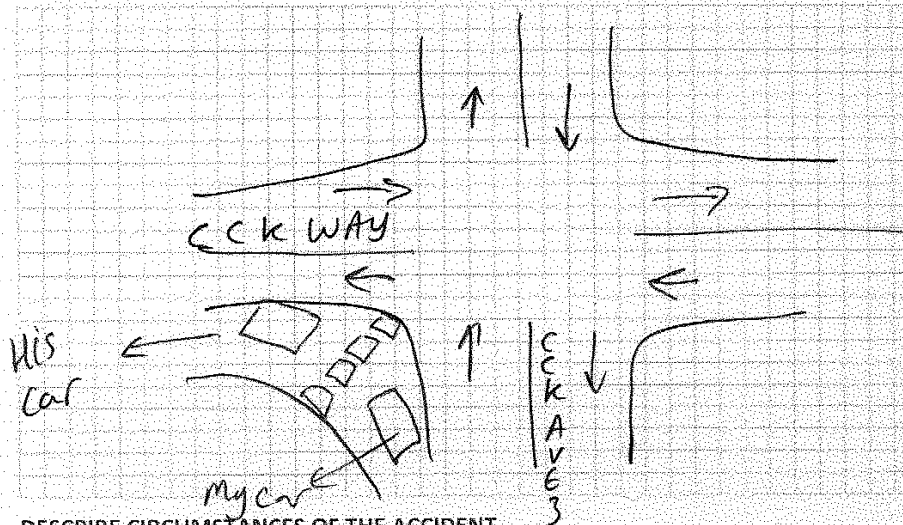

~~The~~ I am the owner of the company which owns the car.

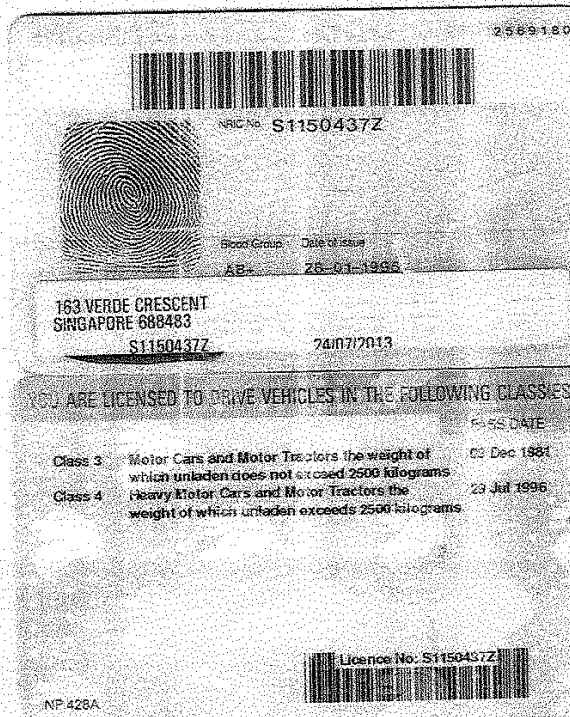
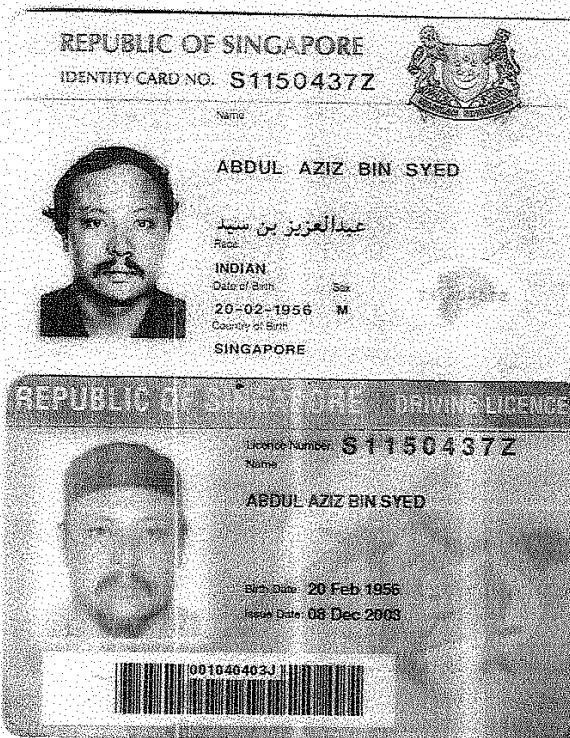

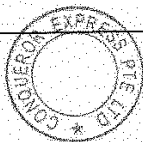
