DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

1. My Car (Car A SKB3813K) was at stationary mode while waiting for the traffic light to turn green.
2. Green light reflect in 30 sec and i saw pedestrian move & other car move out (toward bieford road), I also turn about from my lane. I (SKB3813K) turn to 3rd lane due to car C was turning to 2nd lane.
3. Suddenly car B (SKV 4057P) come out from nowhere and hit onto my left front left portion which across two yellow box from my left.
4. I get down and check my car.
5. Car B (SKV 4057P) mention he follow ambulance and beat red light (I didn't see any ambulance infra drive pass me).
6. Pedestrian (Ms Joyce 93871485) mention car B beat red light and almost hit onto them, they can be my witness.
7. Car B (SKV 4057P) driver Mr Rishi mention to me he was in the yellow box when it was red light and he was afraid that the car on his right side move forward and hit onto him so he continue to drive across the junction.

Brief Details:

On the above mentioned date, time and location, my car (SKB3813K) was at stationary mode while waiting for the traffic light to turn green. When the green light reflect in 30 seconds, I saw pedestrian move and the other car move out (toward Bieford road). I also turn out from my lane. I then turn to 3rd lane due to another car which was turning into 2nd lane. After which the mentioned car (SKV4057P) come out from nowhere and hit onto my left front portion of my car which across 2 yellow box across my left and a pedestrian crossing. I then get down and check my car. The driver of car (SKV4057P), Nandiraju Rishi Bheradwad, S9973677A, hp:91519992 mentioned that he followed an ambulance and beat red-light. However I wish to state that I did not see any ambulance driving pass me. A pedestrian (Joyce, hp:93871485) also mentioned that the car (SKV4057P) did beat the red-light and almost hit onto her. The driver of car (SKV4057P) also mentioned that he was afraid that the car on his right were to move forward and hit onto him as such he continued to drive across the junction.

I wish to state that my car suffer scratches, dent on the left side of the front bumper and also have cracks on the left side of the head light. The head light signal was totally not working due to the accident. I went to see a doctor and the doctor told me that I suffered injuries on my left hip and has muscle stretched on it.
