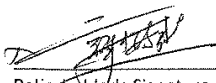
SKETCH PLAN

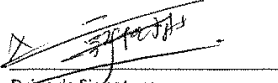

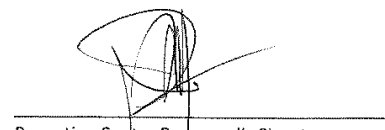
