## Brief Details.

While rider, FBM4088D, was travelling at BKE towards Woodlands Checkpoint, a red car, SMD9322L, was intending to cut cue go get into the first lane hence blocking other road users. After some time and being honked at multiple times by other vehicles, SMD9322L, changed his mind and decided to go further up. The Driver found an opening on the first lane and decided to cut in resulting on the accident. Only rider of FBM4088D was injured at the time of the incident. Rider was still conscious and unable to get up due to sustained injury. Rider was assisted by other road users while waiting for the ambulance to arrive and was admitted to Khoo Teck Puat Hospital.


