

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

Upon the traffic light turning green, the two vehicles in front of vehicle SBK 6767A, did not pre-warn the other drivers behind of their intention of turning right on the traffic junction. Without signalling right on their vehicle, vehicle SBK 6767A (with the intention and assumption the vehicles would all be going straight), the driver made a sudden jammed break as the two vehicles suddenly made an abrupt right turn.

With the sudden jammed break made by vehicle SBK 6767A, driver of PC 6812E reacted promptly and made a safety call at breaking as well. However, due to the existing close proximity between both vehicles, he was unable to avoid a minor surface collision upon the instinctive break. This, therefore, resulted in the minor incident along upper Bukit Merah road, before King Albert Park MKT.
