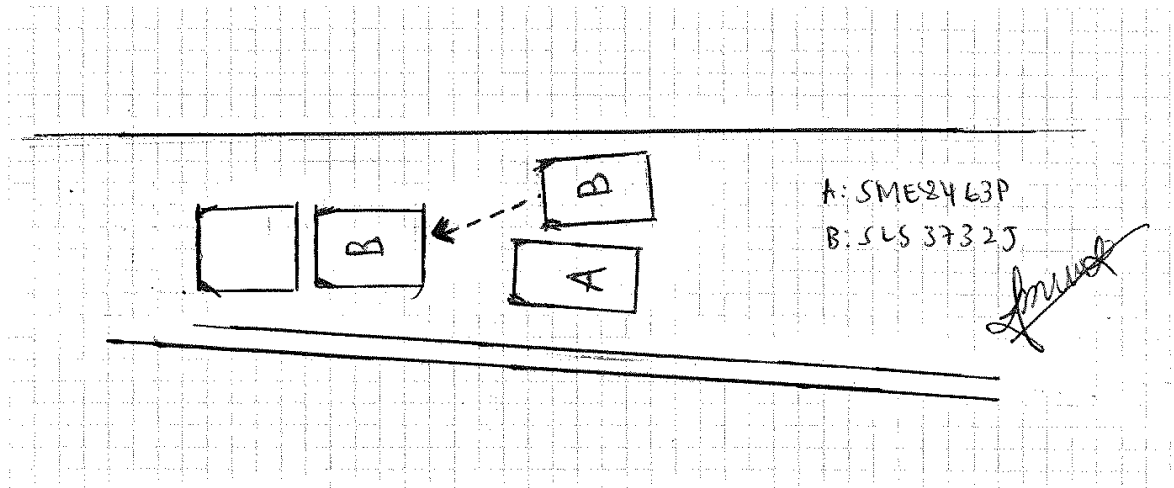

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

Incident occurred on 09/07/2019 at approximately 0715H (or a few minutes before);
After turning right from Fort Road to road leading towards MCE entrance (merging lane),
2 lanes were merging into one and I was the leading car initially.
However, suddenly the car "SLS 3732J" barged in front of my car and hit the right
side mirror in the process. This has resulted in:
① scratch on my car "SME8463P" side mirror on the right.
② Left side mirror on his car was "SLS 3732J" was bent inwards immediately
after.
Immediately, I dialed "999" and called police for assistance as I was afraid of hit and run
police also directed Traffic Police to me as well, when traffic police there after
gave me a return call.
I honked at the vehicle involved to signal them to stop by the roadside, which
both of us eventually stopped within MCE tunnel, by the side shoulder.
He initially refused to give me his contact details, but when traffic police arrived,
he gave.
there were 2 phones he was holding, eventually used the phone to give
me missed call for mobile number recording. Extremely not forthcoming.
