Circumstances of Accident

Refer to Police Report Ref: T/20190705/2062 lodged at Sengkang NPC. On 04/07/2019 at about 1310 hours, I was driving my vehicle SKA2155M on the 1st lane of Compassvale street heading towards Rivervale Drive. I was about to turn into my estate, the cluster of Block 299C Compassvale street and I turned on my left signal lights about 2 car length behind the bus. I notice that there was a bus with his left signal lights on at the bus stop so I decided to overtake the bus and turn into my estate. Just as I passed the bus on my left, I slowed down and turned slightly to my left, I continue slowing down as I observed that there was 2 lays and one of them was pushing a pram talking amongst themselves, I was prepared to give way to them as I am afraid that they might dash across the road. Suddenly, I felt my vehicle surge forward and the 2 malay ladies were right in front of my vehicle. I saw the malay lady pushing the pram to my left. Instinctively, I immediately swerve my vehicle to the right to avoid colliding onto them. Right after I swerved right to avoid hitting the 2 malay ladies and the pram, I notice an indian lady right in front of my my vehicle running away from me. I continue swerving right and applied brakes but ended up hitting the indian lady on her back with the front bumper and she rolled forward. However, my vehicle was still not in my control and I know that there was a tree at the right side so I aimed for the tree to try to stop my vehicle. My vehicle ended up on the left on the tree with my front right wheel hitting the tree, I then immediately shut down my vehicle and tried to exit, a gentleman suddenly ran towards me and asked me how was I and why did I stop my car. I ignored him and climbed out from the passenger side of my vehicle as the estate sign was blocking my driver side door. Pls refer to Police Report for continued statement.

Sketch Plan

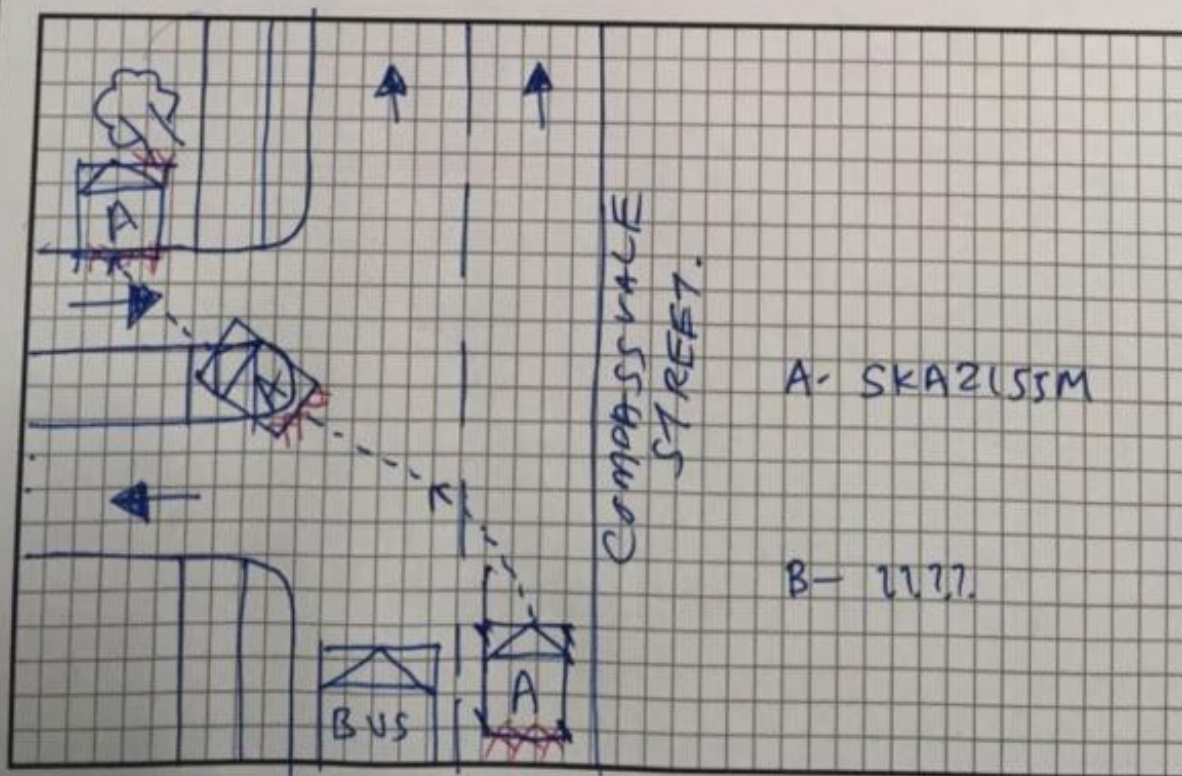

CONTINUATION OF REPORT

Brief Details.

On 4/7/2019 at about 1310hours, I was driving my vehicle SKA2155M on the 1st lane of Compassvale street heading towards Rivervale Drive. I was about to turn into my estate, the cluster of block 299C Compassvale street and I turned on my left signal lights about 2 car lengths behind the bus. I notice that there was a bus with his left signal lights on at the bus stop so I decided to overtake the bus and turn into my estate. Just as I passed the bus on my left, I slowed down and turned slightly to my left, I continue slowing down as I observed that there was 2 lady and one of them was pushing a pram talking amongst themselves, I was prepared to give way to them as I am afraid that they might dash across the road. Suddenly, I felt my vehicle surge forward and the 2 malay ladies were right infront of my vehicle, I saw the malay lady pushing the pram to my left. Instinctively, I immediately swerve my vehicle to the right to avoid colliding onto them. I continue swerving right and applied brakes but ended up hitting the indian lady on her back with the front bumper and she rolled forward. I ignored him and climbed out from the passenger side of my vehicle as the estate sign was blocking my driver side door. After I alight I went straight to the indian lady and I observed that there were a few passerby attending to her and she was crying and she kept saying, 'call my husband'. I then checked with the passerby if ambulance were called and they replied yes, I then checked if they had called for police and they replied no, and another gentleman called the police. Subsequently, I called the indian lady's husband and informed him of the situation. I moved to one side to gather my thoughts and I notice that the rear of my vehicle was dented and damaged, only then it dawned onto me that I was being hit from the rear and it caused my vehicle to surge forward. I took a glance around and I spotted a black vehicle stopped at the main road and the front of the black vehicle was damaged. I shifted my attention to the 2 malay ladies and one of them was seen sitting on the ground, she told me that the rear side of my vehicle actually came into contact with her. While waiting for the IO to speak to me, I suddenly felt dizzy and feel like fainting, I found a spot to sit down and was provided water by the paramedics and a passerby. With the advise of the paramedics, I agreed to go to the hospital for a check up. The ambulance conveyed me to Sengkang General Hospital. Upon arriving at the hospital, I felt pain at my upper back and the neck area. They took X-Rays for me and there seem to be no broken bones. I was discharged and received MC from 4/7/2019 to 7/7/2019. I have an in car camera and there was a traffic police that took my SD card at scene.

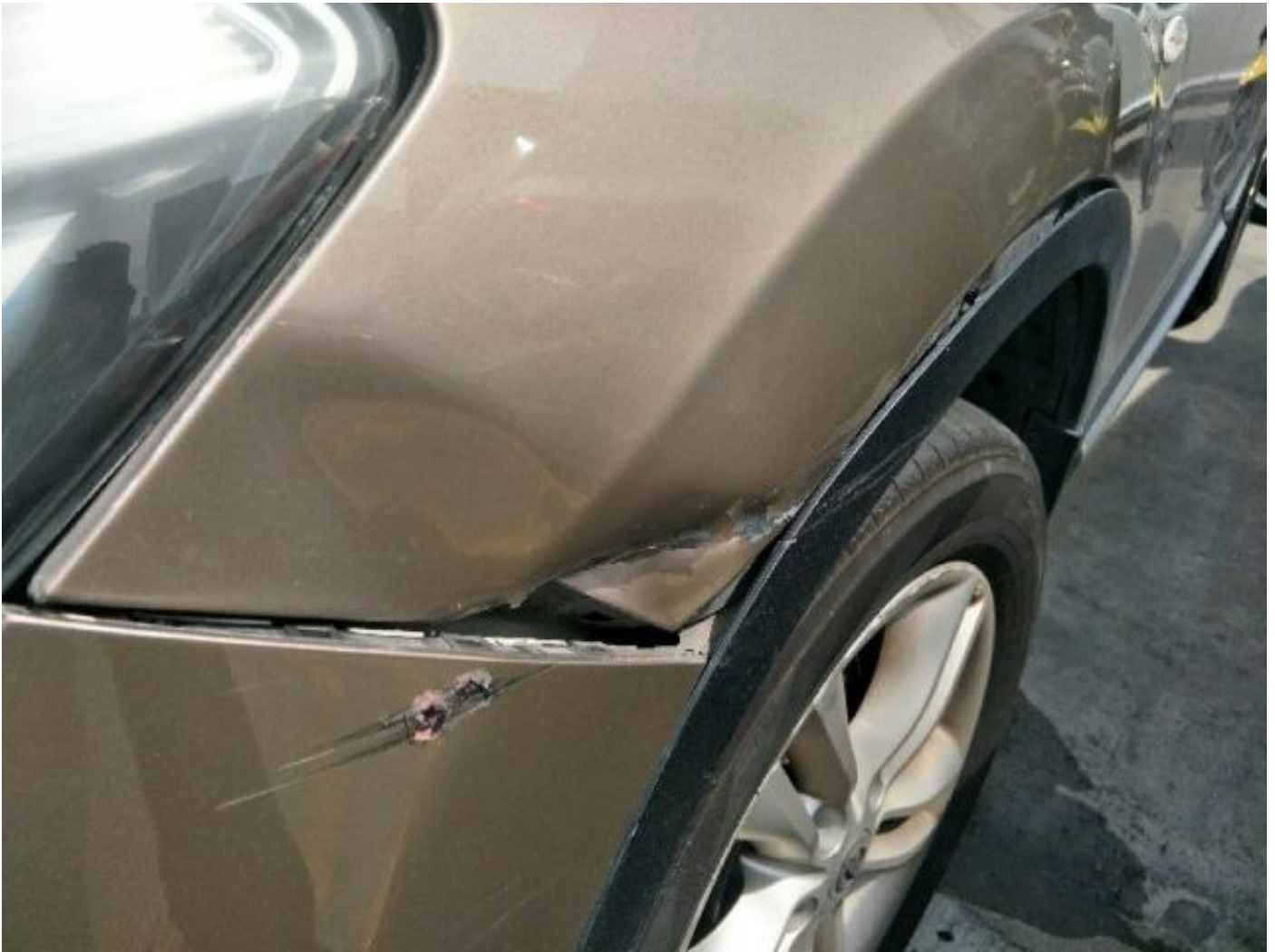
