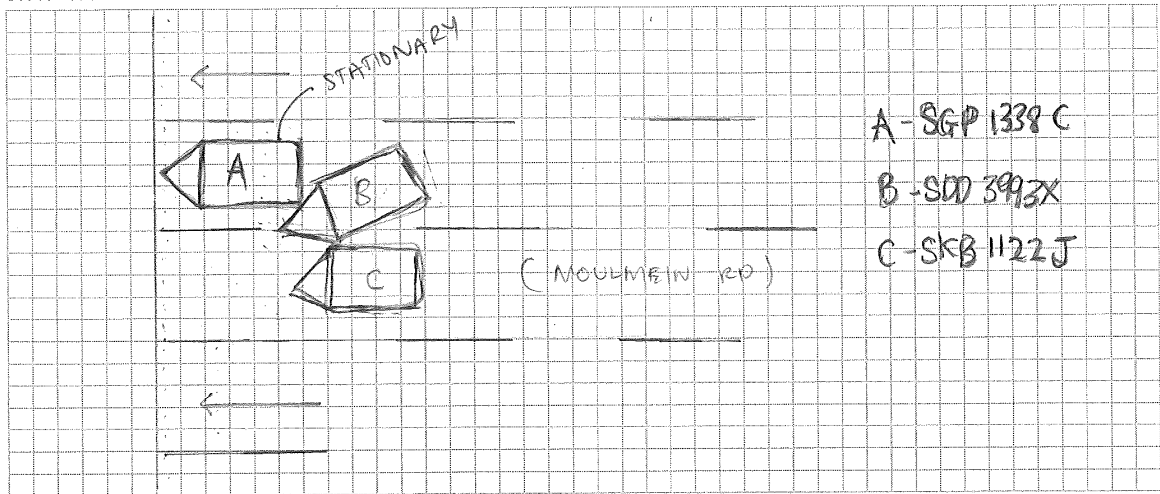

On 02/07/2019, around 0945hrs, whilst I, Rubairad Bin Mohamed Yusof, driver of vehicle no SGP 1338 C (Toyota Wish) was at the junction of Moulmein Road towards Thompson Road (1st vehicle, 2nd lane) in stationary waiting for green light, a vehicle, reg no SDD 3993X, (Mazda Blue), driven by Mr Lim Hen Song, hit the rear left side of my vehicle and eventually hit another vehicle, reg no SKB 1122 J, (Mercedes White), driven by driver Mr Chua See Ngee. We eventually parked safely along Newton Rd and exchanged particulars. Mr Lim admitted that it's his mistake and acknowledged about insurance claimant against him.
