ON 10 JULY 2019, 4:56 PM, I WAS DRIVING MY GREY AUDI Q2 (SMA 2436 D) STRAIGHT ALONG CHANGI SOUTH AVE 1. AS I WAS REDUCING MY SPEED, PREPARING TO MAKE A RIGHT TURN AT THE NEXT TRAFFIC LIGHT TO CHANGI SOUTH STREET 2 SUDDENLY A RED CAR MODEL KIA (SCK 8188 X) EXITED FROM SINGAPORE EXPO CARPARK J, ABRUPTLY MAKING A RIGHT TURN CUTTING A CROSS 3 LANES TO THE OPPOSITE DIRECTION, WITHOUT CHECKING FOR INCOMING TRAFFIC. THE MOMENT I SAW THE RED COLOUR CAR DASHING OUT FROM THE CAR PARK. IMMEDIATELY I DID AN EMERGENCY BRAKE . THE RED CAR TURNED OUT SO FAST THAT I COULD NOT BRAKE IN TIME TO AVOID THE COLLISION. 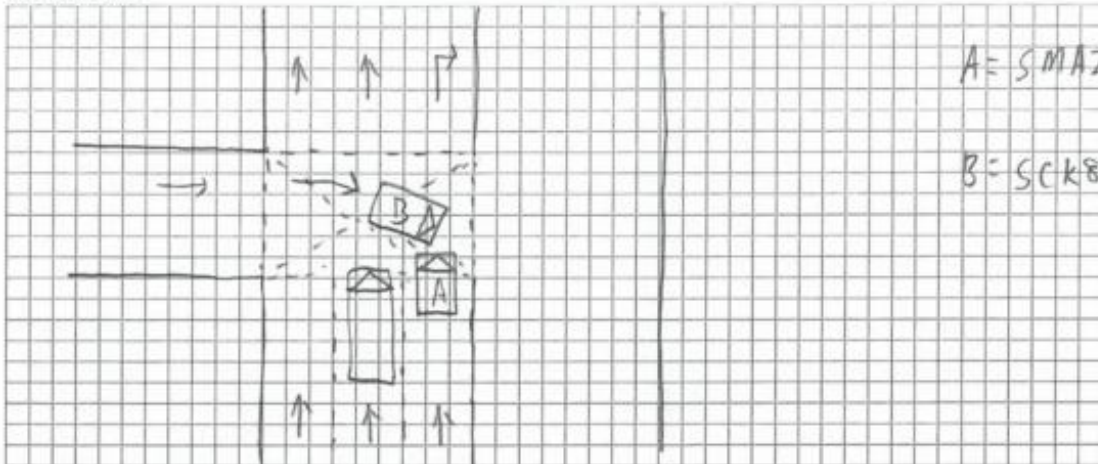

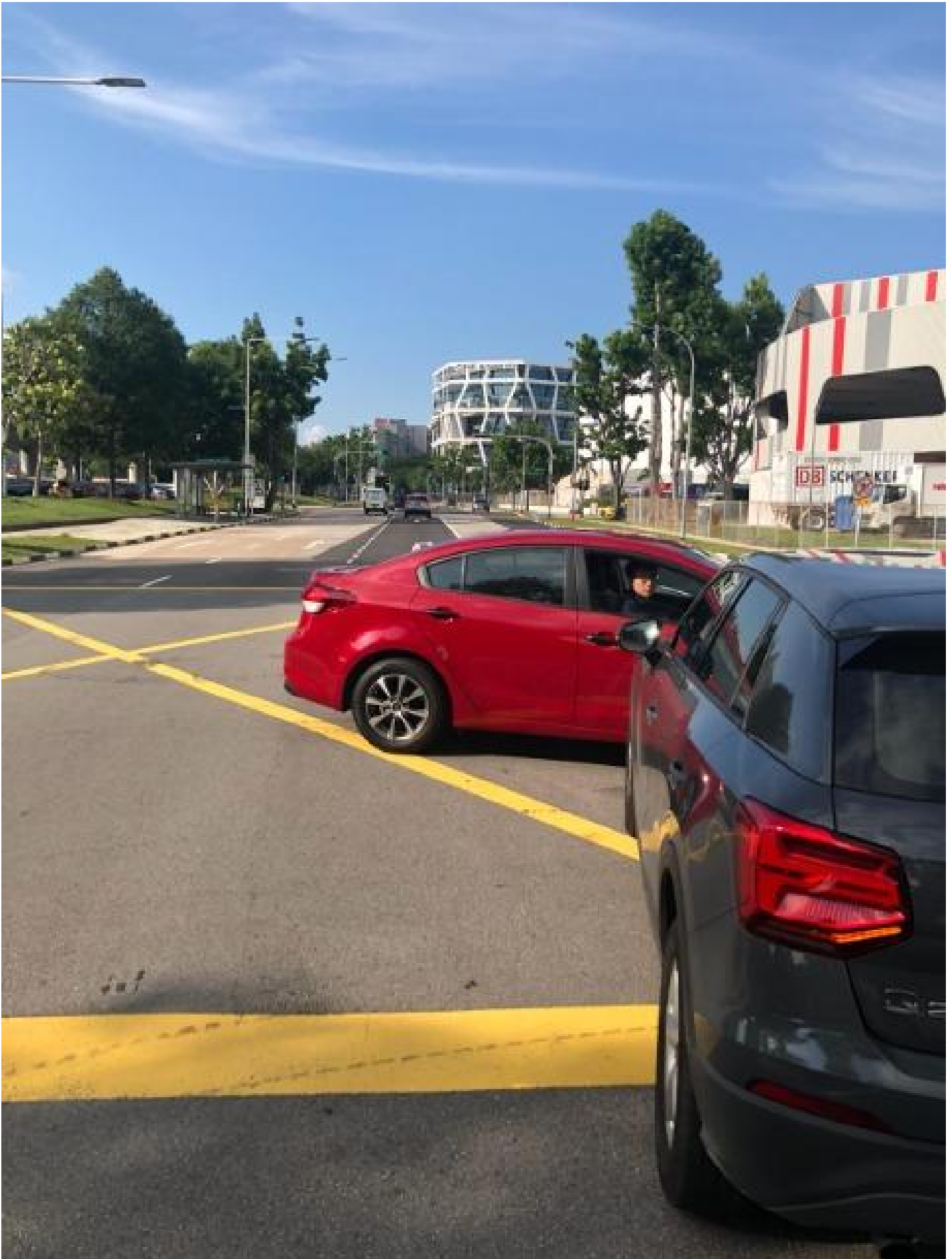

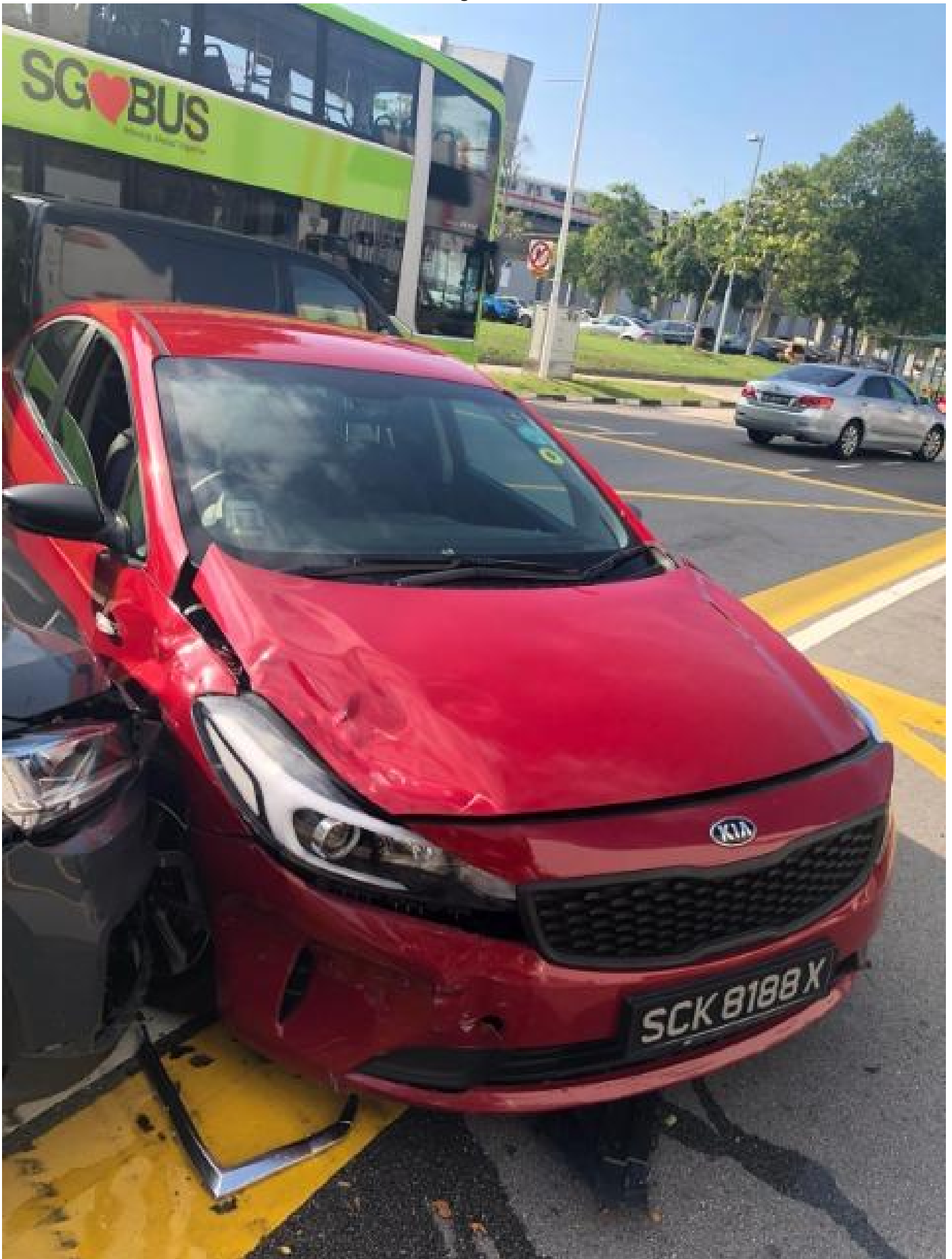
