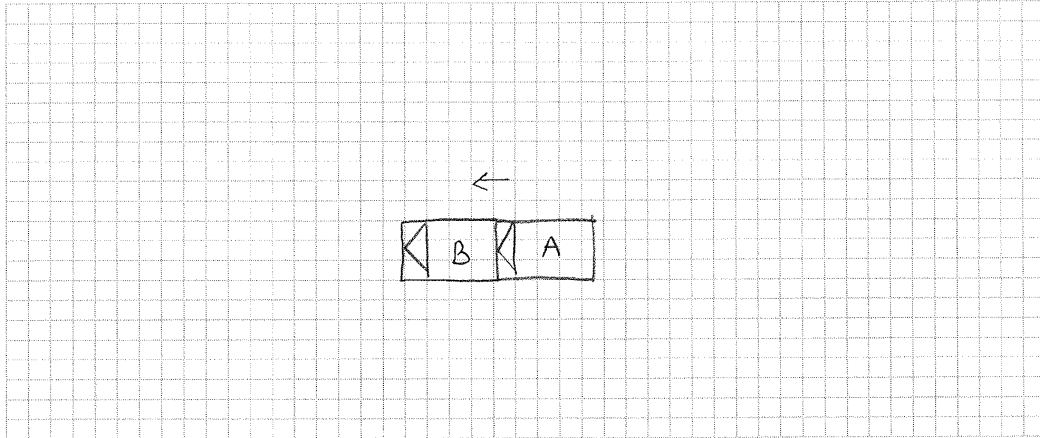

SKETCH PLAN



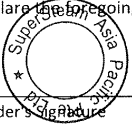

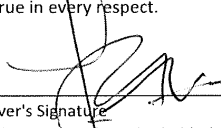
Traffic light was Red. My vehicle slowly move forward ~~at~~ and hit the vehicle in front of me. There was no injury involved.
