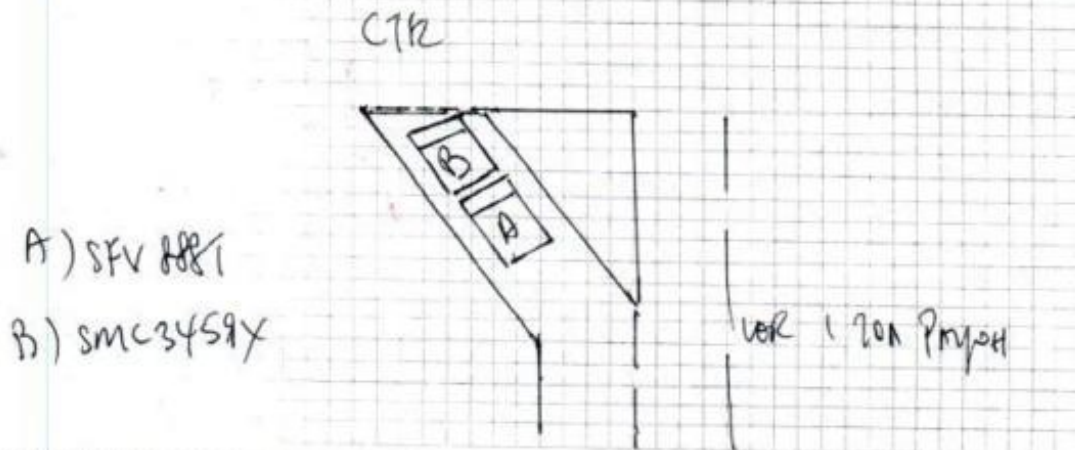

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

Was at the slip road turning when I hit the car in front of me. Location was the junction of Lor 1 Ton Poyoh turning onto CTE.

There were cars having right of way and I was behind the other vehicle. The driver moved forward, and so I released my brake. As there were no oncoming cars, I did not expect the driver to suddenly hit the brakes, so the front of my car hit the back of hers. Impact was light, my vehicle sustained only a dented car plate. Car itself was fine.

As the damage was minimal, I exchanged details with the owner but when asked if she intended to claim she said no doubt so, and I left it at that. Am surprised she eventually did file
