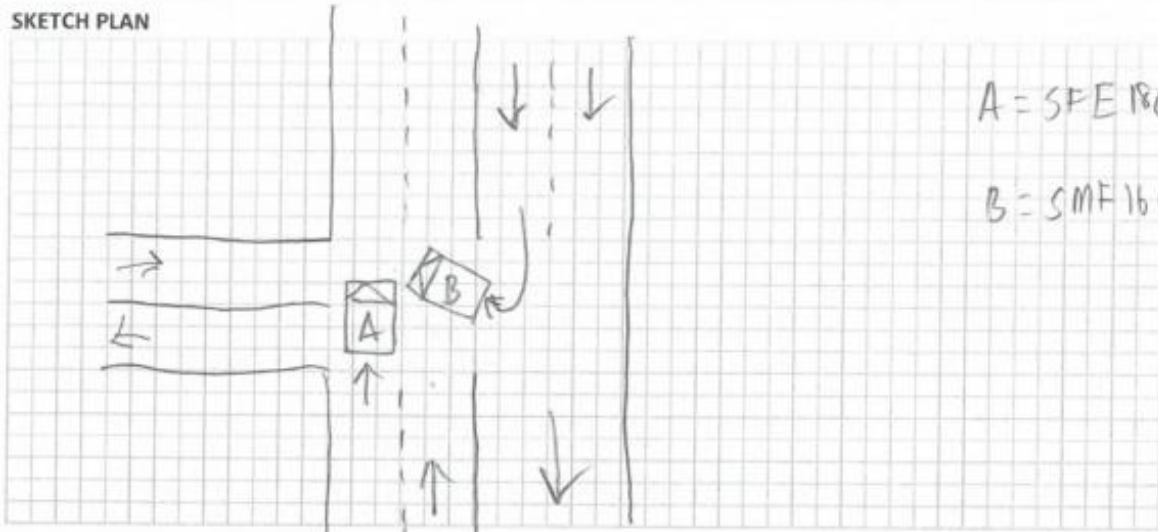

I, Koh Joo Ling (S8019114F) was driving along Hougang Avenue 1 in Vehicle A, maintaining an average speed of around 50km/h. Weather condition was good and road surface was dry. I was travelling straight on the left lane of a two-lanes straight road and traffic lights was in my favour.

Vehicle B from the opposite traffic flow suddenly accelerated and made a sharp U-turn into my right of way.

I immediately sounded my horn and swirled my vehicle further to left to avoid a head-on collision, and braking at the same time. However, I am unable to avoid a collision as vehicle B had already cut partially into my lane. There was an impact.

I alighted from my vehicle when it was safe to do so. I approached driver of vehicle B. At first, the driver was reluctant to exit from her vehicle, claiming that nothing had happened. I told her it was only right that we exchange our particulars and to assess damages to our vehicles.

The driver then alighted. The driver claimed that she is rushing to bring her maid to the doctor as she is very sick and also she needs to fetch her grandchildren. I noticed there was one person at the front passenger seat of vehicle B. I would assume that person is the maid that she referred to in her claim.

We then assessed our vehicles' damages and took photographs of the damages. At the same time, we also exchanged particulars. Driver of vehicle B was Sania Binte Ahmad (S1412200A).

No parties were injured.

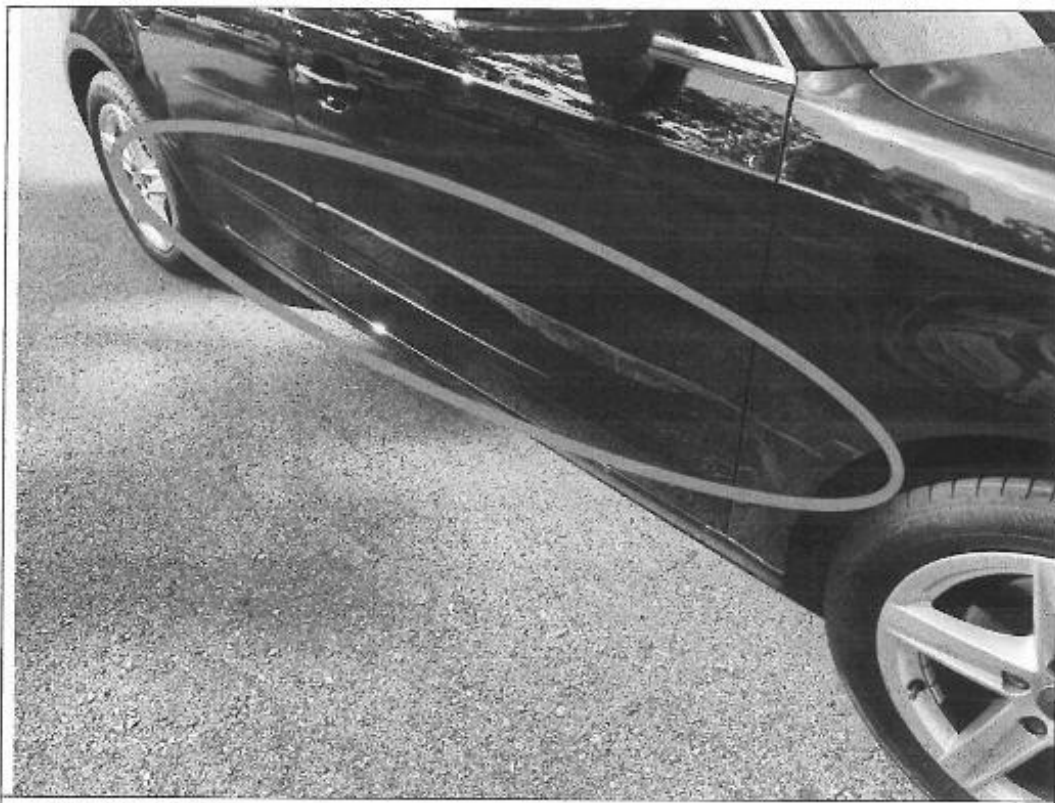
My visual assessment:

1. Damage to vehicle A includes visible deep scratch marks and possibly dents and misalignment to right rear passenger door, driver door, rear and front fender areas. **[Refer to images 1, 2 and 3]**
2. Damage to vehicle B includes scratch marks to number plate and holder, and front left bumper. **[Refer to images 4 and 5]**

I surveyed and noticed there is no U-turn sign on the road that vehicle B was traveling in.

**My front and back in-car dashcams recorded footages leading to the accident. I provide here as evidences to my statement of account.**

I will be sending my vehicle (vehicle A) to Audi workshop on 13 Jul 2019 for a proper damage assessment.

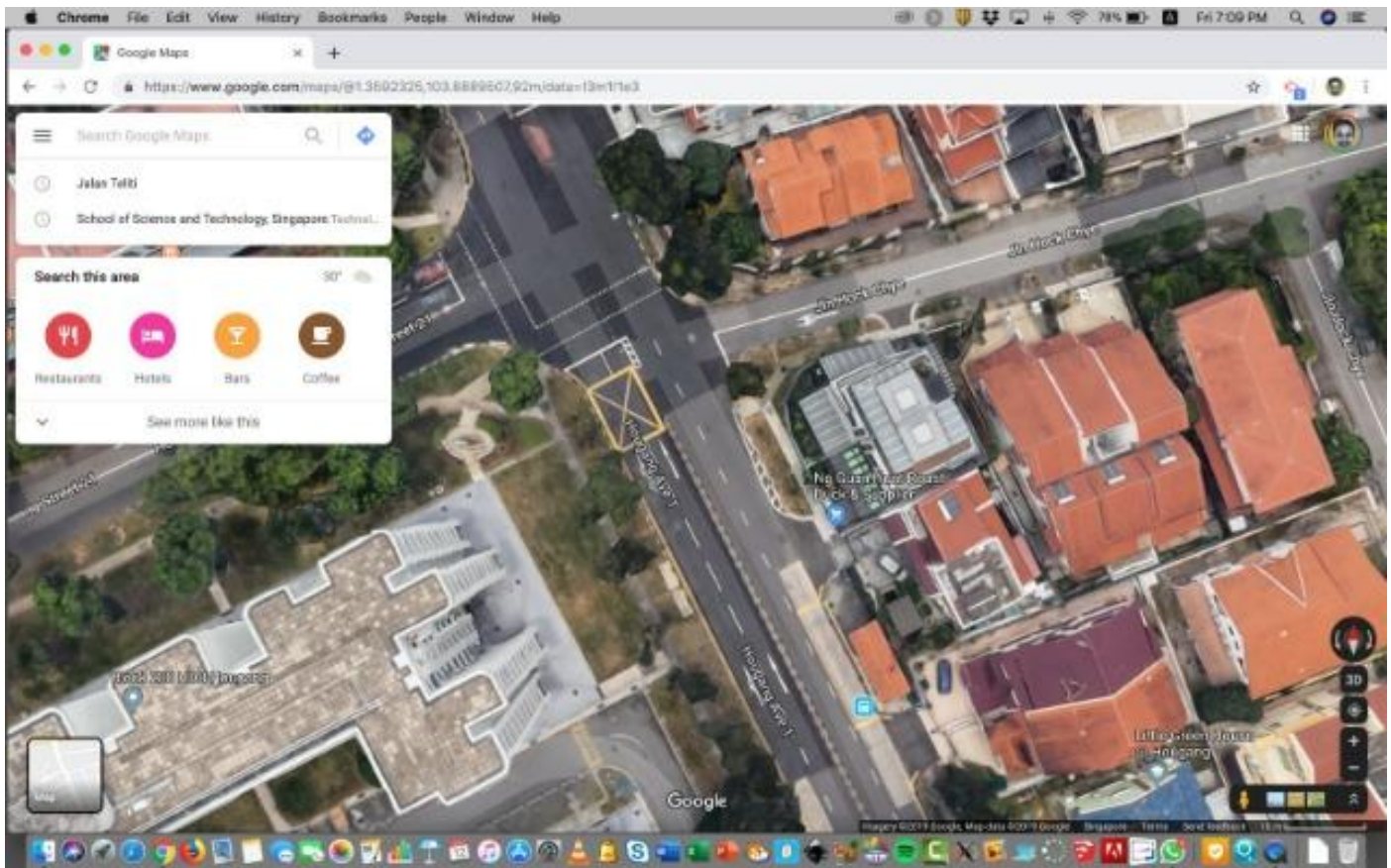
