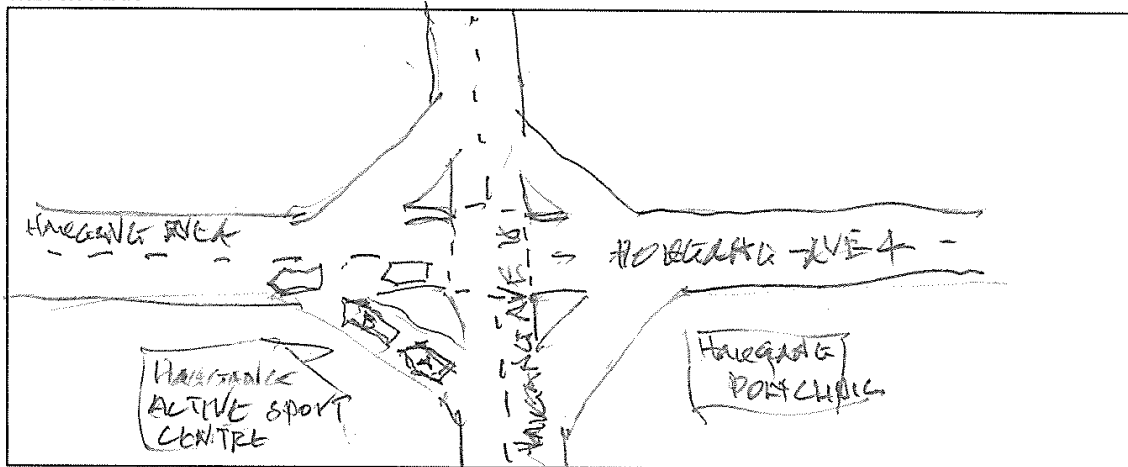

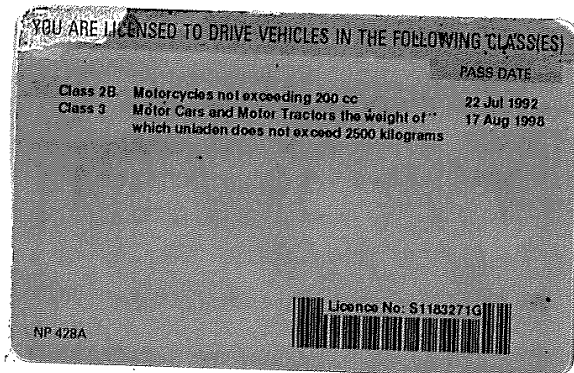
Important note
