Brief Details.

On the above mentioned date and location. I was driving my car along the straight on the 2nd lane of the expressway. As I was going straight, suddenly the car in front (SJZ715R) jammed braked and stopped. I applied my brakes and was able to stop in time. But unfortunately, the car at the back could not stop in time and collided at the back of the car. Due to the impact, my car jerked forward and hit the front car. I approached the drivers and we exchanged particulars. No one sustained injury and all the cars were damaged.

I wish to state that I have the video footage of the accident. Both my passenger and myself felt pain, sore and unwell after the accident. The driver of SJZ715R called for police assistance however we left prior to the arrival of police. We proceed to move off to put my car in the workshop before going to the hospital with my passenger (wife). However before going to the hospital, we receive a call from Traffic Police to go down to Traffic Police headquarter to lodge a police report.

My passenger and I went to Mount Alvernia Hospital for medical treatment and received 5 days' of MC. I felt pain and sore on the back, the rear of my neck and also unwell. My passenger felt pain and sore on her left shoulder, waist, back area and also giddiness.
