**Background**

This is an accident involving your OI vehicle GBF 1829P and GY 4971 G at the control junction of Kranji Way and Sungai Kadut Drive on 23.10.2018. The passenger in GY 4971G has commenced proceedings against your OI and OID. They are in the process of serving the WOS and SOC on your OI and OID. I shall write to Plf's sols to accept service of process.

Your OID in his police report stated that he was making a right turn at the control junction of Kranji Way and Sungai Kadut Drive. The lights were showing green arrow when he started to make the right turn. The GY 4971 G that was travelling on the opposite direction instead of stopping at the control junction carried on to travel into it. OI's vehicle driven by your OID collided into the side of GY 4971G.

The Drive of GY 4971Y stated that the lights were showing amber when he was near the stop line. He therefore carried on travelling into the junction when your OID travelling on the opposite direction made right turn and collided into the vehicle he was driving.

The police investigation is inconclusive. No action taken.

In the absence of any police action and independent evidence, liability would most likely be apportioned equally between your OID and the driver of GY 4971G

We also will ascertain if Plf has withdrawn his claim under WICA.

**Quantum**

The owner of GY 4971 G is making a PD claim. The owner is claiming a sum of S\$9000.00 and S\$3240.00 for COR and rental. Your surveyors are conducting a re-survey of GY 4971G on 18.6.2019. We shall advise you on quantum shortly.

### Conclusion

I suggest that you offer to contribute 50% toward liability for now. As for quantum, we shall revert to you once we get the re-survey report.

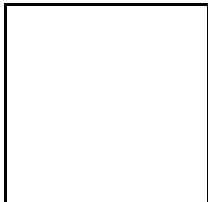
