CONTINUATION OF REPORT

Brief Details.

On 26/06/2019 at about 1500hrs, I was at ESSO Petrol Station (Taman Jurong) when I last saw my vehicle (Grey Volkswagen Tiguan bearing plate number SGZ213H) intact and with no damages while I was filling up petrol.

On 29/06/2019 at about 1000hrs, I was about to drive when I discovered that there were damages (scratches and dents) to the front left bottom area of my vehicle, near to the front left wheel. The damages seemed to be caused by collision between vehicles.

On 26/06/2019 from 1500hrs till 1830hrs, I was driving the vehicle around and did not alight from the vehicle at any point of time. At 1830hrs, I parked the vehicle at level 2B Multi-Storey Car Park (MCSP) of Blk 660 Jurong West St 64.

On 27/06/2019:

At about 0730hrs, I drove the vehicle to my workplace and parked the vehicle at level 8 of Tradehub 21 (18 Boon Lay Way), at Lot number 25.

At about 0900hrs, I left my office and drove to my client's office at Changi Aviation Park. I parked the vehicle at the one of the corners of the sheltered open carpark inside Changi Aviation Park (unsure near to which office).

At about 1500hrs, I left Changi Aviation Park and headed back to Tradehub 21. At about 1600hrs, I parked the vehicle at the open carpark of Tradehub 21, near to "O Bar".

At about 1800hrs, I left Tradehub 21 for home. I parked the vehicle at level 2B Multi-Storey Car Park (MCSP) of Blk 660 Jurong West St 64.

On 28/06/2019:

At about 0730hrs, left for office and parked the vehicle at level 8 of Tradehub 21, Lot 25 as well at about 0805hrs.

At about 1730hrs, left for home and parked the vehicle at level 2B Multi-Storey Car Park (MCSP) of Blk 660 Jurong West St 64 at about 1830hrs. That was the last time I parked my vehicle before I discovered the damages on 29/06/2019 morning.

I wish to state that from 26/06/2019 at about 1500hrs to 29/06/2019 at about 1000hrs, I am sure I did not hit or collide onto anything while I was driving. I have made a check on the in-car camera footage (only turns on when the engine is running) and no discoveries of any collisions were made.

I also wish to add that I am the only one driving the vehicle during the said timings.

I have since already informed Volkswagen about it and they had assessed the cost of damage to be around SGD\$8000. I was then advised to lodge a Police report.

I do not have any recent or prior disputes with anyone and I do not have any suspect in mind. However, based on my assessment, the collision might have happened at the open carpark of my office (Tradehub 21) as the carpark lots are very narrow.
