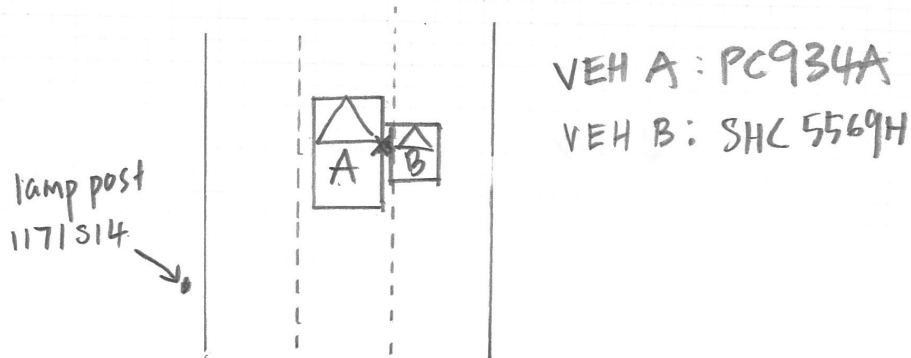

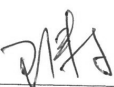
## DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

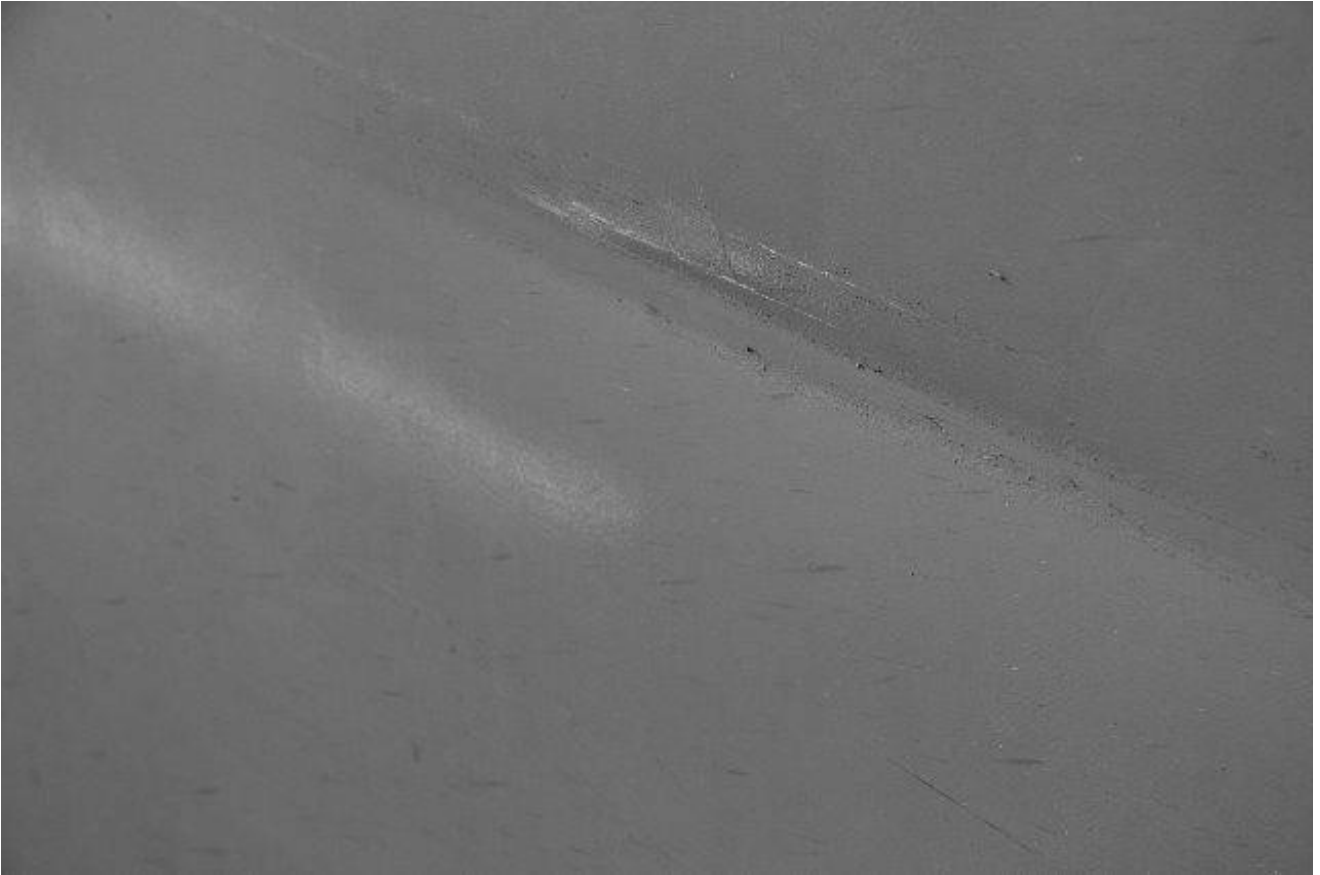
