

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

I WAS DRIVING FROM NEWTON CIRCUS TOWARD BUKIT TIMAH ROAD ON THE 3RD LANE OF A 4 LANE ROAD. SOMEWHERE NEAR SIDE ROAD OF THE SCOTTS ROAD, VEHICLE (U) SMF 3760 J DROVE FROM THE 2ND LANE AND SUDDEN MAKE A SORT LEFT TURN INTO SCOTTS ROAD. THUS, I APPLIED BRAKE AND STOPPED. AFTER A FEW SECOND, I FELT AN IMPACT FROM THE REAR PORTION OF MY VEHICLE. AFTER THE ACCIDENT, I ALIGHTED AND REALISE THAT VEHICLE (B) DROVE FROM THE REAR AND COLLIDED ONTO REAR PORTION OF MY VEHICLE.
