“We/I, **EROFIA MOTOR TRADING PTE LTD** (“the workshop”) hereby confirm that we/I have reached an agreement with the appointed surveyor of AIG Asia Pacific Insurance Pte Ltd **LKK AUTO CONSULTANTS PTE LTD** (name of surveyor) with respect to the amount claimed for **S\$3,586.00** (Total Loss Value), **S\$320.00** (Loss of Rental/Use), **S\$--** (Disbursement), for vehicle no. **FBJ 9121Z** that was damaged pursuant to the accident which occurred on **12/07/2019** (date) along **GAMBAS AVENUE** (location) involving vehicle no/s **SGW 19T**. This is pursuant to the inspection conducted on **12/07/2019** (date) at “the workshop”.

We/I confirm that we/I are/am authorized by the owner **CHEONG CHEE BOON JEFF** (“the third party claimant”) of vehicle no. **FBJ 9121Z** make the claim as set out in the above paragraph and we/I have full authority to settle the matter on his/her behalf in a manner that we/I deem fit.
