


SKETCH PLAN

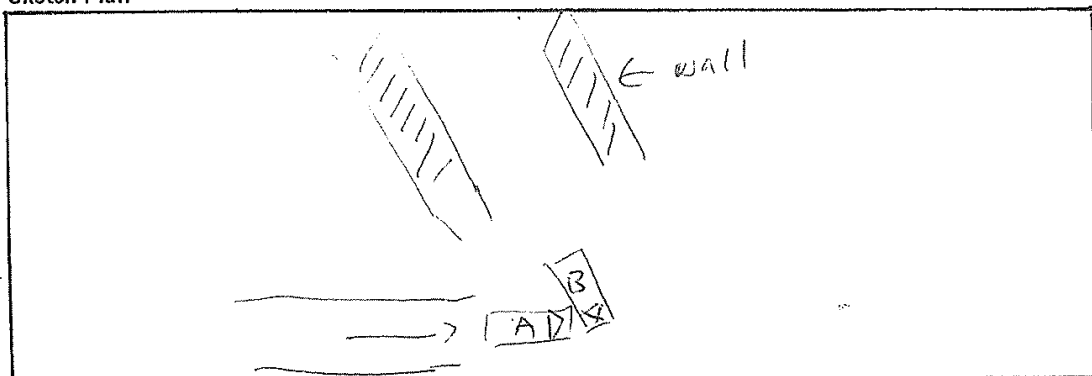
