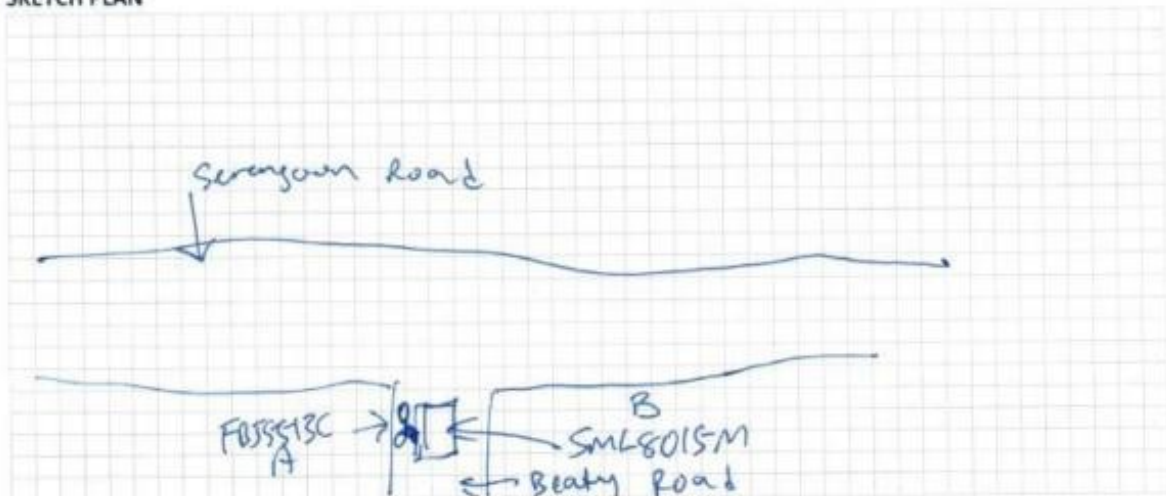

### DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

On the material date and time I was travelling along Beatty Road with intention to turn onto Serangoon Road. Beatty Road was jammed up with cars. I used my motorcycle to squeeze through the traffic.

When I arrived at the last car and about to turn onto Serangoon Road, I misjudged the gap inbetween the pavement and the vehicle SML801SM. As a result my Right Side pillion grazed lightly onto the rear left portion of SML801SM.

The driver got out (male Chinese) Took pictures while I balanced my bike to keep from falling, caught against the vehicle and the pavement. After he took the pictures, we both turned left onto the side of Serangoon Road and alighted. I noticed 1 female Chinese passenger in the front passenger seat.
