


Accident Sketch Plan

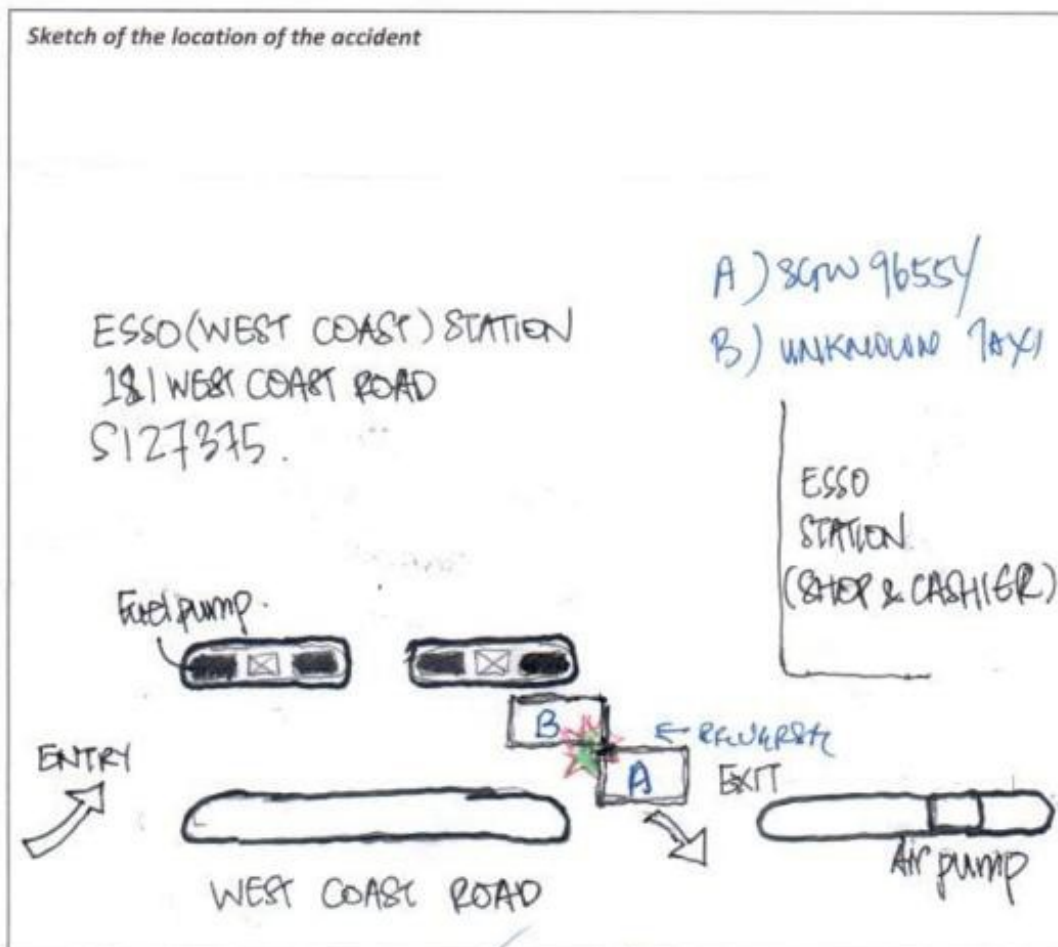
On 20 July 2019 (Saturday) at approximately 11.30am, I patronized the Esso West Coast station at 181 West Coast Road Singapore 127375.

After refuelling and making payment, I proceeded to drive my vehicle over to the tyre air pump station. I reversed my vehicle after completing pumping my tyres in order to exit the station. While reversing, I did not notice that a vehicle (blue taxi) had parked adjacent to the fuel pump nearest to the exit.

My vehicle grazed the side of that vehicle very slightly. Reference to the pictures of the graze, it was hardly noticeable. I immediately got out of my vehicle and offered to pay for the damage caused.

Unexpectedly, the driver of the vehicle hurriedly took some pictures, refused to respond other than grumble some profanity, and drove off immediately before I could even take down any of his particulars.
