Brief Details.

On 19/07/2019 at about 1840hrs, I was driving my car (SH7012C) along Pandan Loop. While I was turning into 213 Pandan Loop, a lorry (YN2529J) from the opposite direction overtook another lorry. YN2529J then hit onto the front left of my car.

The following are the damages done to my car
