

**Brief Details.**

On the 22/07/2019 at about 2155hrs I was driving my vehicle (SJM2440M) along Upper Changi Road East, heading towards PIE. Before entering into the filter lane leading to a round bend into PIE, there were 4 lanes and I was at the last lane. It was the only lane that enters into PIE. Before the entrance into the bend, a vehicle (SMG9876P) made a rush signal and cut into my lane, seemingly trying to squeeze into the only lane that enters PIE.

While doing so, the said vehicle collided into the front right of my vehicle, as the driver did even notice my vehicle beside her. Moments before the accident, I was already slowing down from 60km/hr to get ready to enter the bend.

We then got down our vehicles after the accident and exchange particulars. The ambulance and police were not required to attend to us and no one was injured then.

We then drove off after agreeing to settle the accident with our insurance company.

The front right of my vehicle, near the driver door, sustained scratches and dents.

Subsequently, the next morning, I discovered that my right portion of neck and back felt sore and stiff. I went to see a doctor and was given 3 days of medical leave. Hence, I am lodging this report due to injuries discovered post-accident.
