Would wish to re-emphasize that the traffic light is green with right turn arrow but suddenly turn to green without arrow.

We should not be fully liable as the motorcyclist is at the extremely lane (ie lane 3) and just like the centre lane (lane 2) vehicle, they have ample time to react rather than our vehicle, which is half way turning.
