Kindly let us know if you concurred.

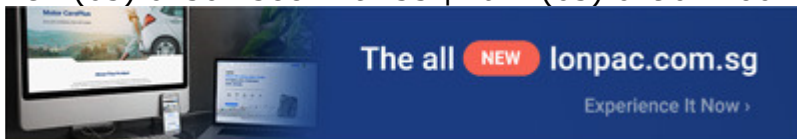
